



#### All about Tracking Articles

#### Introduction

The stated purpose of a CKC tracking test is "to demonstrate the dog's willingness to work with its handler under a variety of conditions and to follow a defined track, to discriminate scent, to locate and indicate articles". The dog must find the articles on the track in order to pass. Test articles should be approximately 4" x 6", able to be retrieved by the dog (if that's the way the dog indicates) and of a colour that doesn't contrast greatly from the surface where it is placed. All levels of test tracks have a scent pad at the start and a leather article at the end. The TD test track has a final article only, but all other levels have at least one intermediate article. Urban tracks will also have start article available, scented by the track layer, for the handler to use at the start of the track, if desired, to orient their dog to the scent of the track layer. The purpose of the start article is to allow the dog to differentiate between the track layer's scent and the scent of any other people or animals that may have contaminated the start pad before the dog runs the track.

<sup>\*</sup> As of Jan. 1, 2020, a start article is available in urban tests to allow the dog to determine what scent to follow at the start if the start pad might be contaminated by persons other than the track layer. It will be fabric or leather and may only be used to start the dog on a test track, not to re-scent the dog after the official restarting distance as outlined in the Tracking Test Rules and Regulations.

#### What is an Article Indication?

The judge will ask you how your dog indicates articles before your dog starts its track. Your dog will not be judged on how well it indicates. The judge wants to know what to look for to verify that your dog has recognized the article, rather than the handler noticing an article that the dog did not actually found.

There are several different ways a dog might indicate an article.

A dog can stop and lie down, sit or stand at the article.

A dog may retrieve the article to its handler.

A dog may nod briefly at the article and continue tracking.

A dog may freeze and stare at the article.

Or a dog can do anything else that makes it clear to its handler that it perceives an object to be an article, including vocalizing, tossing it in the air, etc., even peeing on the article (not recommended!)

#### Which Indication is best?

The best indication is one that is clear to the handler and that the dog is happy doing. There are several considerations (pros and cons) in choosing an indication to train.

Can you easily recognize that the dog has found an article? A brief nod at the article as the dog tracks past it can be easily missed by a handler that isn't paying very close attention to the dog at all times. If the cover on the track is very high and the dog is not tall, you may not be able to see the dog at all times on the track and miss the indication if it is very brief.

Is the dog comfortable doing the indication? Older dogs and dogs with mobility issues might be reluctant to lie down if they experience discomfort in lying down or getting up from a down position. Is your dog willing to lie down if the cover is prickly or otherwise nasty? Will your dog lie down if the cover is wet or muddy?

- Is the dog in a good position to restart the track after indicating the article? A down is considered the best indication to set the dog up for a good restart from an intermediate article, as the dog will most likely be exactly on the track at the article with its head close to the track. A dog that retrieves the article may not be on the track when it delivers it to the handler if the handler is off the track.
- Is the indication behaviour clear enough that you won't mistake it for other behaviour such as squatting to pee (sitting looks similar) or 'sight seeing' (a dog stopped to investigate an unrelated scent may look similar to a dog pointing at an article while standing over it).

In summary, the best indication for you and your dog is one that is clear to you and that the dog is not reluctant to offer. Your dog doesn't have to give a picture-perfect indication in the test. The judge may see that your dog has found the article before you recognize his indication since the judge knows where the article is and will be watching your dog carefully at that place on the track.

#### **Teaching the Indication**

Traditionally, the indication is not considered to be of primary importance in the early training, but it is necessary to train an indication before you trial your dog. However, some people train the dog to indicate the article first before they begin training tracking (see below). Once your dog has an understanding of what tracking is, you can gradually introduce an article indication. Some tips:

- If your dog naturally gives you a crude indication, then you may want to work with that. For example, some dogs naturally pick up and retrieve any article they find. If your dog naturally stops and investigates the article, you can reward interest in the article.
- Begin by putting an article down at the end of every track and start to build value in the article. Communicate to your dog that you are happy he found the article. Do this with verbal praise, food rewards, play at/with the article, etc. Don't skip on the praise, reward, play because you need the dog to think that finding and indicating the article is very important to you.
- Initially, you may reward the dog verbally for just sniffing the article. You can encourage a sniff/stop by putting food in or on the article. You will need to eventually fade the food in/on the article, but it can create interest in the article for a novice dog. Follow sniff/stop with more food or play. For food-motivated dogs, you can drop the food on the article as the dog is stopped and looking at the article in order to reinforce his interest in the article. If your dog is not food motivated, and even if it is, play with the dog once it has found the article. For dogs that are not motivated by food or play, you can act very pleased and excited by the article.
- Once the dog is stopping for the article and the praise, food, or play reward, you can begin to ask for whatever extra behaviour you would like i.e., a retrieve or a down, sit or stand, stare/freeze or a bark.
- Alternatively, you can shape the indication behaviour away from a formal track. Throw a glove out on your lawn while the dog watches. The dog will likely go to the glove and briefly sniff it. Click and feed the sniff. Ask for a bit more each time maintaining the sniff for more than a brief instant. You can gradually extend the length of time the dog stares at the article by tossing food directly on it from above the dog's head. Alternatively, you can then add a command for down or sit or retrieve, if that is your chosen indication, and insist on the indication before giving the food reward and play session.
- Some dogs prefer to continue on the track rather than stopping and indicating an article. CKC tracking is not meant to be an obedience exercise. However, once a dog has been taught to indicate an article, you should insist on an indication if the dog has noticed the article, but chooses to ignore it. In this case, stop and refuse to let the dog proceed on the track until it acknowledges the article. For dogs that like tracking, their reward for indicating is to be allowed to proceed with the track.
- In training, if the dog has missed the article on a track and doesn't notice it, decide whether that is what's of primary importance on this particular track. There may be situations where you don't want to interrupt a dog's momentum on a track by insisting on coming back and finding the article. At other times, it's worth drawing the dog's attention to the article and insisting on an indication.
- You can intensify the article indication training by laying short, simple tracks with multiple articles spaced 5 or 10 meters apart.

When your dog's article indication is really solid, you can occasionally leave the article a short distance (1 or 2 m) off a training track to test if your dog will notice an article from a couple of meters away. Sometimes a dog is tracking a short distance off a track due to wind or other factors. Other times an article may have moved somewhat due to wind or a passerby picking up and then discarding the article. By proofing an indication of an article a few meters away, you may save your dog from failure in a test.

Alternatively, some trainers start novice dogs on article indication as the very first step in their training. Typically, they begin by teaching a freeze on a small object, such as a coin, a bottle top or a similar sized object. Dogs are rewarded for freezing by tossing food on the article. Once the freeze behaviour is solid, dogs are asked to find the object (article) on a scent pad. The next step is to have the dog leave the scent pad and track a very short distance to the article where he is rewarded for finding and freezing at the article. Gradually, the length of the track to the article is lengthened until the dog is tracking a reasonable distance to the article. The idea is to make the article of such value that the dog drives to find in by following the track. Since the article is very small, the dog must follow the track very closely if he is to find the article. This approach would be useful for dogs that are not keen on stopping for the article.

#### What articles to use for training

Training articles must be fairly large (approximately 10 cm x 15 cm or 4" x 6"), but in training you may want to use smaller articles to encourage accuracy on the track and discourage the dog from visually scanning the environment for the articles. However, if your dog is inclined to eat non-food items like toys, etc., you should use articles that are large enough and or rigid enough that they can't be swallowed. Alternatively, you can use articles that are so samll and inert that a dog could swallow the article with no ill effects.

Training articles should be safe for dogs that may pick them up in their mouths. Gloves should be clean and free from oil or other toxic contaminants. Rigid plastic articles, such as 'jewel cases' used house CDs and DVDs could shatter into sharp pieces if driven over in a parking lot.

In urban areas, use articles that are inconspicuous so they will not draw attention from a passersby. People may pick up articles and move them in urban areas. Occasionally, wildlife may pickup articles in fields. If an article attracts attention from people or animals, your training track will be contaminated to some extent and you may lose your article permanently.

In training, use articles that the dog will not be able to spot from a distance. It is okay if a dog sees an article from a few meters away, but you don't want the dog to abandon tracking to scan for articles. This can be a particular problem on hard surfaces in urban tracking. A single large work glove in the middle of a parking lot can be seen from quite far away. Training articles on hard surfaces like parking lots should be thin and ideally close to the colour of the substrate. However, mark the location of all articles on your tracking map, so you can retrieve any articles that your dog misses.

Your dog may air-scent the article before he sees it. He may leave the track and cast about for the article. This is okay and you probably don't want to discourage the dog from actively searching for the article. As a handler, you need to understand what your dog looks like when it has sensed that the article is nearby and is looking for it.

#### How to use articles in training

When carefully placed, articles can be used to reward your dog for overcoming an obstacle or navigating a difficult element on the training track. Small articles can be substituted for food drops in urban areas or whenever insects, wildlife or other dogs might be attracted by the smell of food. Very small articles that have little odour can encourage more advanced dogs to stay very close to the track. Larger articles, such as work gloves, can serve as a toy for a play reward.

If you intend to train your dog for urban tests, use a mix of articles in your training so that your dog recognizes articles of different composition (leather, fabric, wood, plastic and metal). Leather has its own unique smell and, as a result, is generally easy for dogs to locate. Dogs may have more trouble with plastic, wood or metal articles. Fabric isn't usually a problem for dogs. Use regulation articles occasionally so your dog understands that articles can be of any size.

All articles used on a track should be scented by the track layer. The track layer can tuck articles next to her skin behind her belt, or hold them in her free hand while laying the track. In colder weather, she can tuck articles into her glove or mitten to scent them. I use a very large oversized mitten on my left (non-dominant) hand so there is room for several small articles inside it that will be scented as I lay the track. Although a dog will not be penalized in a test for indicating articles not associated with the track layer, I prefer to have my dogs indicate only the articles touched by the track layer. A dog that indicates every possible article on a track may waste time and effort indicating non-articles unnecessarily.

#### In the Test

When your dog indicates an article on a test track, you should pick it up and hold it briefly in the air for the judge to see. Keep the article in your pocket or tracking bag because you will need to show the judge the article(s) at the end of the track to verify that you and your dog actually found the articles left by the track layer.

Occasionally an article is missing from the test track. It may have been moved by an animal or passerby or the wind may have blown it off the track. Your dog will be credited with finding the article so long as he was tracking close enough to the original location of the article before it went missing. Some dogs will sniff intensely where the article was originally placed and or actually indicate the place where the article should be. If the article is very close to its original placement, your dog may find the article anyway. When an article is missing, the track layer will confirm where it was originally placed and if she cannot find it quickly then it will be assumed to be missing. The judge will make a final decision as to how far off the track an article can be moved before it is considered so far that the dog cannot reasonably be expected to locate it.

#### Fun fact about dog's nose..

Did you know that the tiny vertical groove between your dog's nose and lip has a special function?

This groove is called a filtrum and it helps to keep the nose always moist.

Whenever the dog licks its lips, the saliva accumulates there and goes up to the nose through the capillary.

And why is it important?

Because a damp nose captures and retains air odors much better, making dog's smell incredibly powerful!
