VISITOR CONCERNS AND STATEMENTS County Commissioner Kam Washburn	Washburn reported the recent activity by the County Commissioners, including: the Commissioners have determined the Clinton Area Transit Authority millage question will be on the November 2016 ballot.
	The remonumentation project, which measures and verifies the corners of the County, Townships and sections within the Townships, is 2/3 complete.
	The County is in the final stages of negotiating the new healthcare contract. Washburn anticipates the new contract will have a less than 3% increase employee costs.
	Washburn said that while the Commissioners are aware that the City of St. Johns is undergoing an internal investigation, he has been assured it is not financial in nature.
	The County has not heard anything from Forest Hill Energy since their special use permit expired.

MRFR run report	Gavenda reported that Maple Rapids Fire and Rescue has been on 15 medical runs and six fire runs so far in 2016.
TREASURER'S REPORT Banking options	The Treasurer reported the general fund balance is \$139,787.91. She reviewed income and expenditures since the last meeting. 95.2% of Township taxes have been collected. George also reported she has investigated several local banks and credit unions to determine if there is a better option for Township banking. She has discovered that all the local banks she spoke with charge for ACH payments (electronic payments, which is how tax allotments are distributed). At this time, George has determined it is in the Township's best interest to remain with Mercatile Bank. Bunn moved to accept the Treasurer's report as presented, supported by Ferguson. MPC.
CLERK'S REPORT	Bunn reviewed the general ledger for the fiscal year and reviewed checks #5593-5613. She also reviewed the fiscal year-to-date financial report.
