## A Year in Review: The Victim Services Professional Network [VSPN]

June 4th, 2012, begins the annual five day training week for another Roper Victim Assistance Academy. Much planning and preparation takes place prior to recruitment, orientation, and workshop facilitation. On the first day, participants applications now match their faces, relationships begin to be forged, and memories that will last a lifetime start to be built. It is the charge of the Victim Services Professional Network (VSPN), the alumni association of RVAAM, to help make this week a success. This charge will be accomplished, however this year it will be bittersweet. As VSPN graciously welcomes a new Executive Board, it will also bid a fond farewell to a number of its board members.

The Roper Victim Assistance Academy alumni nominated Co-Chairpersons, Linda Wright Fair and William "Archie" Griffin, to serve a two-year term beginning in 2008. At the completion of their first term, the alumni reelected them to serve another two-year term. The experience and knowledge gained through this leadership opportunity was priceless.

These two individuals served the organization faithfully and tirelessly, and always focused on how they could "get the job done." Their efforts were matched by an amazing group of board members who supported and embraced Linda and Archie's vision, and together worked as a team to spearhead a number of successful campaigns.

One of the most significant accomplishments this group made was to create a new identity for the organization that would help to further distinguish its mission from the mission of the Academy. The alumni association was developed in response to the request of the inaugural graduating class from the 2004 RVAAM Academy. It was their desire to be advocates beyond the Academy experience by fostering relationships, building networks, and influencing policy to improve the field of victim services. Therefore to honor this mission, the board wanted to rebrand the RVAAM Alumni Association. To do this, the board developed a campaign and solicited ideas from RVAAM alumni to help create a new logo and name for its alumni association.

So many wonderful ideas were submitted, but the board settled on the Victim Services Professional Network [VSPN], and awarded the alum who submitted this name with a gift card to Giant Food. Archie then worked diligently to create a new logo for VSPN, which was premiered back in 2010. The board and

> fellow alums have since spent the past two years promoting VSPN in the field, and for their efforts, we believe everyone now knows who we are and what we do.

VSPN has worked diligently to nurture alumni relationships by hosting annual summer and fall gatherings for alumni and their families. Some of these outings included a cookout, a holiday party, and a group sporting

event. VSPN also found ways to engage with the community and assist others in need. #### **Best Practices**

Why the Academy is for me: Two criminal justice professionals share how the Roper Victim Assistance Academy of Maryland helped guide them on their paths of victim advocacy

Tips for healthy victim advocacy I learned at the Academy - by Kim Truitt

I received my certification from the Roper Victim Assistance Academy of Maryland (RVAAM) in May 2011. For me, the Academy was more than just a training, it was a once in a lifetime experience. When I attended, I was working at the Maryland Crime Victims Resource Center as a victim advocate, and I currently am a law student at the University of Baltimore. The knowledge and skills I gained during my week at the Academy not only have helped me as a victim advocate, but also as a law student.

My classmates at the Academy were comprised of other victim advocates, social workers, law enforcement officers, faith leaders, and students - all of whom came together to discuss how we can better help crime victims. By having such a diverse set of individuals with varying degrees of experience and different perspectives, we were able to work together as a group to generate ideas and solutions that many of us have struggled with when dealing with victims of crime.

One of the most important lessons I took with me from the Academy was the importance of self-care. Every day we take on other people's problems, and internalize a lot of of what we have hear or see without really realizing it. I had no idea how much trauma I have encountered and taken on vicariously through my work as a victim advocate. The Academy provided us with helpful techniques on how to help ourselves while helping others, and thereby reduce our chance of burnout. Throughout the week we practiced many of these techniques, and I found myself able to "let go" and relax. More importantly, I still use many of these techniques today when I get stressed with law school or upset from cases I am assigned at work.

Another benefit of being a part of the Academy is the networking opportunities you have with your fellow peers and the trainers. Since the Academy, I have reached out to a number of my classmates to help me with some of my cases. By obtaining the help and advice of my

peers, I have been able to provide much better care for my clients.

I am so grateful for my time at the Academy and all of the valuable information I learned. It was an amazing week and is an experience I will never forget.

## The Power of the Academy - by Keith Gethers

Twenty-three years ago, I joined the Prince George's County Police Department for the same reason many young men and women do: to make a difference. On one assignment after another, however, I found myself in some of the busiest and most dangerous areas of the county that was plagued by many of the common ills of urban life. For example, I would routinely go to the scene of a routine domestic disturbance and restore peace by convincing one party to leave, only to be called back to the same residence repeatedly. During that first year on the job, I learned that making a difference was truly a relative idea.

So I grew accustomed to enjoying small successes, and it wasn't long before I got the hang of it - lending a helping hand, listening a little longer, taking detours to check on the young and the old. These were all things that conceivably could be linked to making a difference, one person at a time. I realized that helping others was my primary reason for showing up to work. But then suddenly, it was all over. I thought my opportunity to help was gone with my unexpected retirement.

In 2011, however, I was hired by the Maryland Crime Victim Resource Center and was given the opportunity to attend the Roper Victim Assistance Academy. I anticipated that during the five day training I would learn a number of things, such as advocacy and how to provide direct assistance to victims. Well, day one of the Academy was the only day that met my original expectations.

The compelling nature of days two through five of the Academy was abso-

lutely life changing for me. First, through classroom activities I discovered I was part of an extremely diverse group of peers (male, female, young, old, Black, White, Hispanic, Christian, Jewish, Atheist) brought together by our common interest in assisting others. Second, the cadre of supportive staffers and volunteers demonstrated through both word and deed what it is to truly be a service provider: interjecting their perspectives where appropriate, providing guidance during and after class, rendering muchneeded assistance during the numerous times when students were emotionally overwhelmed by the subject matter. And finally, the expert level of instruction we received revealed the many harsh realities that crime victims are forced to face, and the challenges providers deal with while rendering assistance to them.

Almost every block of instruction drew me further into a web of interest that has now become a passion. By the end of the week, I had a new group of friends, a new outlook on life, and renewed sense of excitement. Thanks to my Academy experience, I hope to embark on a new career path as a therapist. Once again, I know I can make a difference - one person at a time.
