- The election of Region officers is called to order
- Please verify we have a quorum
- The voting members will be nominating the following officers
  - Chair
  - Vice Chair
- The voting members will be electing the following officers
  - Secretary / Treasurer
- We will begin with the office of Secretary/Treasurer
- Are there any nominations from the floor? Are there any *other* nominations from the floor? Are there any *other* nominations from the floor?
- \*Hearing no additional nominations I would entertain a motion to close the nominations and elect XXXX to the office of Secretary/Treasurer for Region XX by acclamation. I have a motion and a second? All those in favor say “YES”. All those opposed say “NO”. Are there any abstentions? Motion carries. XXXX is elected to the office of Secretary/Treasurer.

office of Secretary/Treasurer. (At this point paper ballots are distributed to the voting members and collected and counted. The ballots are to have the position identified at the top and list the names. The vote can circle the name of choice. After verifying the count the elected individual is announced and the ballots are maintained by the Secretary.
