# **MINUTES**

The May 10, 2016 regular meeting of the Innsbrook Board of Trustees was held at Innsbrook Village Hall and called to order at 7:30 PM with Village Board Chairman Jeff Thomsen presiding. Chairman Thomsen led the Pledge of Allegiance. Upon Roll Call, Trustees Jerry Rust, Ted Sator, Tom Stevener, Trish Dunn and Jeff Thomsen were present. After roll call Chairman Thomsen announced that a quorum was present for the transaction of business.

Also in attendance were Village Administrator/Clerk, Carla Heggemann; Rich McFall (L2210), Doug & Glenda Rice (L1102), Bud Oldani (L860) and John & Linde Flanders (L971).

### APPROVAL OF AGENDA

Chairman Thomsen asked for a motion to approve the May 10, 2016 agenda. Motioned by Trustee Rust, seconded by Trustee Stevener, to approve the agenda. All Trustees present voted "Aye". Motion passed with a 5-0 vote. Motion was approved.

### APPROVAL OF MINUTES

Chairman Thomsen asked for a motion to approve the April 12, 2016 Minutes. Motioned by Trustee Rust, seconded by Trustee Stevener to approve minutes from the Regular Meeting on April 12, 2016. All Trustees present voted "Aye". Motion passed with a 5-0 vote. Motion was approved.

### PUBLIC COMMENT

Doug Rice (L1102) presented the Board of Trustees with a petition for an Ordinance on Rental Properties in the Innsbrook Estates Lake Charrette Plats. Lake Charrette properties are mostly residential and this petition is in response to unresolved issues which began in 2012 when a property was offered as a vacation/short term rental. The Ordinance, if enacted, would prohibit all property within the Lake Charrette plats from being utilized as Vacation Rental property. Chairman Thomsen wants to run this petition and Ordinance by the City Attorney and will advise Doug Rice of the outcome. This issue will be tabled until the City Attorney can look into this further.

a. Nomination and Election of Chairman and Village Board Clerk - Chairman Thomsen stated that every time an election is held, the Board of Trustees must elect or re-elect a Chairman and Village Board Clerk. Motioned by Trustee Rust, seconded by Trustee Sator to re-appoint Jeff Thomsen as Chairman of the Board of Trustee's for one year. By roll call vote, Trustee Rust "Aye", Trustee Sator "Aye", Trustee Stevener "Aye", Trustee Dunn "Aye", Trustee Thomsen "Aye". Motion passed with a 5-0 vote. Motion was approved. Motioned by Trustee Stevener, seconded by Trustee Sator to appoint Jerry Rust as Village Board Clerk of the Board of Trustee's for one year. By roll call vote, Trustee Rust "Aye", Trustee Sator "Aye", Trustee Stevener "Aye", Trustee Dunn "Aye", Trustee Thomsen "Aye". Motion passed with a 5-0 vote. Motion was approved.

- a. Financial Report The financial report and the bills of the month were distributed and viewed by all Trustees in attendance. Motioned by Trustee Stevener, seconded by Trustee Rust to approve financial report and pay all bills of the month. All Trustees present voted "Aye". Motion passed with a 5-0 vote. Motion was approved.
- b. Administrator's Report
  - i. Adopt-A-Hwy Events Step Up TLP has agreed to help with the program once again this year. Rick Schmitt has stated that unfortunately the community volunteer numbers have gone down. The program is in desperate need for volunteers and an article will be put in the Village Newsletter asking for help.

- c. Planning and Zoning Commission Meeting held on April 6, 2016.
  - i. Reappointment of Bob Soderholm and Allen Huddleston to Planning & Zoning Commission Motioned by Trustee Rust, seconded by Trustee Stevener to appoint Bob Soderholm and Allen Huddleston for a four year term. All Trustees present voted "Aye". Motion passed with a 5-0 vote. Motion was approved.
  - ii. Appendix A Update/Sewer Issues Bob Soderholm was not present for an update. Continued to next month.

- Set Public Hearing on June 14, 2016 for 2016-17 Budget The Trustee's agreed to hold a Public Hearing beginning at 7:30 on June 14, 2016 prior to the Board of Trustees meeting.
