**CAAS Report:** Supervisor Thelen attended the monthly meeting which entailed a long discussion on the job managements description and how future work situations should be handled. There was well over two hundred runs this month and the Ambulance Authority is running on a well managed budget.

**Treasure's Report and Approval of Bill Payments:** Treasurer Roof gave her report by asking that the Profit and Loss and the Balance sheet of the previous month be approved and that checks # 14545-14560 plus EFTPS an ACH be approved for payment. Motion by Graham to accept the Treasure's report and to pay said bills along with EFTPS and ACH.\*Seconded by Smith \* Motion passed.

**Correspondence**: Various Assessor and State required reports were due and handled by our Assessor Beth Botke and Supervisor Thelen. All reports are finalized. The Township has been notified of the many drains that will be worked on this summer. Residents will be notified if it will involves any of their land. A news letter from Greenbush Township are included with the tax notices and entail information on voting, and Township accomplishments .Sample ballots for the August Election are available at the Township Hall.

Public Comment ( on anything other than agenda items): Clinton Transit will be available for free rides to and from polling places for the August Election. Inflation is taking a toll on residents taxes. If your received notification to give your input on the St. Johns School bond issue make sure you check the due date because it has been extended. There will be discussion at the next School Board meeting as to when they might try conduct another bond issue vote.

**County Commissioner Report-Val Val-Shirey:** Many topics were brought up by Val-Shirey that she reported on, which is significant significance to our Community and

**Assessor Report-Beth Botke**: Via text Message\* One resident has filled with the tribunal for residential property that will be addressed at the July BOR. Botke has been out measuring and the tax roll is all balanced so taxes can be distributed.

## **OLD BUSINESS**

\* Road Report- Skip patching will begin on Hyde Rd. Gravel contracts will begin in July on various roads. It was reported to the Board members from residents that they felt the spread of chloride was not done in an efficient manner and not all of the road got a through covering. Supervisor Thelen checked into this and the RC did give the Township a price break for proper coverage was not done. Our second application of chloride will be put before the 4<sup>th</sup> of July. A reminder from the Township Board that there will be a Road Millage Renewal on the August ballot.

\*Removal of Road contract from the table- Motion was made by Kindel to remove Road contract from the table for discussion .\* Seconded by Smith \*Motion passed. Since there will be at least 3 tubes replaced on Williams Rd .between Marshall Rd. And Hyde Rd. The thought of doing the chip seal at this time might cause small bumps in the road. The Road contract is all financially budgeted but another concern was if we did the project that we might have to redo parts of the road and spend more funds. The Board members had legitimate concerns and had a productive conversation.\*Motion was made by Thelen to go forth with this Road contract\* Seconded by Kindel \*A roll call vote was taken\*3 Aye 2 Nayes\*Motion passed

\* PC-14-24-24 MA- The zoning ordinance was looked over by the Township Board and had questions answered by the party that had submitted the zoning request. All were in agreement that this request would be a good fit for our Township and that Clerk Smith should respond to Zoning for the request to move forward.
