AN ORDINANCE LICENSING AND
REGULATING THE RETAIL SALE OF
CIGARETTES AND CIGARETTE
WRAPPERS.

C. W. Carlson, being duly sworn on oath says; that he now is, and during all the times
herein stated has been, the publisher of the newspaper known as The Melrose Beacon, and has
full knowledge of the facts herein stated.

That for more than one year immediately prior to the publication therein of the printed

hereto attached, said newspaper was printed and published in the English language from its
known office of publication within the City of Melrose in the County of Stearns, State of Min-
nesota, Thursday of each week in column and sheet form equivalent in space to at least 450
running inches of single column two inches wide; has been issued from a known office estab-
lished in said place of publication equipped with skilled workmen and the necessary material
for preparing and printing the same; The Melrose Beacon has had in its makeup not less than
twenty-five per cent of its news columns devoted to local news of interest to said community it
purports to serve, the press work of which has been done in its said known office of publica-
tion; has not been entirely made up of patents, plate matter and advertisements; has been
circulated at and near its said place of publication to the extent of 240 copies regularly delivered
to paying subscribers; has been entered as second class mail matter in the local post office of
its said place of publication; that there has been on file in the office of the County Auditor of
said county the affidavit of a person having first hand knowledge of the facts constituting its
qualifications as a newspaper for publication of legal notices; and that its publishers have com-
plied with all demands of said County Auditor for proofs of its said qualification.

THE VILLAGE COUNCIL OF THE
VILLAGE OF NEW MUNICH,
STEARNS COUNTY, MINNESOTA DO
ORDAIN AS FOLLOWS:

Section 1. License Required.—After
December 31st, 1941, no person shall di-
rectly or indirectly or by means of any
device keep for retail sale, sell at re-
tail, or otherwise dispose of any cigar-
ette or cigarette wrapper at any place
in The Village of New Munich, Stearns
County, Minnesota unless a license
hereof shall first have been obtained
as provided in this ordinance.

Section 2. Application and Issuance.—
Application for such license shall be
made to the village clerk on a form sup-
plied by the city. Such application shall
state the full name and address of ap-
plicant, the location of the building and
the part intended to be used by the ap-
plicant under such license, the kind of
business conducted at such location, and
such other information as shall be re-
quired by the application form. Upon
receiving such application with the clerk, it
shall be presented to the village council
for its consideration, and if granted by
the council, a license shall be issued by
the city clerk upon payment of the re-
quired fee.

Section 3.—The fee for every such li-
cense shall be \$12.00 per annum. Every
such license shall expire December 31st
next after its issuance. For any license
issued after January 31st in any year
the fee shall be computed at the rate
of \$1.00 for each month or fractional
part of a month covered by the license.
Licenses shall not be transferrable from
one person to another.

Section 4. License shall be displayed.—
Every such license shall be kept conspic-
uously posted about the place for which
the license is issued and shall be exhibit-
ed to any person upon request.

Section 5. Restrictions. — No license
shall be issued except to a person of
good moral character. No license shall be
issued to an applicant for sale of cigar-
ettes to any place other than his estab-
lished place of business. No license shall
be issued for the sale of cigarettes at a
movable place of business; nor shall any
license be issued for the sale of cigar-
ettes at more than one place of cigar-
ette business. No person shall sell or give away,
or otherwise dispose of any cigarette
wrapper to any person below the
age of 18 years. No person shall keep for
sale, sell, or dispose of any cigarette
containing opium, morphine, Jimson
belladonna, strychnia, cocaine,
or any other deleterious or
poisonous drug except nicotine.

Section 6. Revocation.—Every such li-
cense may be revoked by the council for
violation of any provision of this or-
dinance if the license has been given a
reasonable notice and an opportunity to
be heard.

Section 7. Penalty.—Any person who
violates any provision of this or-
dinance shall be guilty of a misdemeanor
and upon conviction thereof shall be
punished by a fine not exceeding \$100
or by imprisonment in the county jail
not exceeding 60 days, or by both such
fine and imprisonment.
