#### **Qualifications for Artwork (contact show chairperson if you have questions with these):**

This show will be displayed in a smaller gallery space, therefore, the size of artworks must be considered. The painting should not exceed half-sheet size (15" x 22" before framing).

Artwork must be original in design, concept, and execution. Works to be done in transparent watercolor and/or in another aqueous medium, as follows: acrylic applied in a transparent manner, gouache, casein, or as an aqueous media collage.

**This show has the theme “Essence of Autumn.” Artists are asked to submit works that are inspired by the concept of autumn, however the artist wishes to interpret that.**

Do not submit work copied from another artist, a picture or photograph that has appeared in print, or works done in a workshop or class. No works previously shown at a Wows juried show may be submitted.

Artwork must be wired and adequately framed for support. Sawtooth hangers cannot be used. All artwork must remain on display until the show closes on the final day.

**Liability and Sales:** Every precaution is taken in handling entries. No loss or damage to artworks during the exhibit will be assumed by Western Ohio Watercolor Society or the YSAC. Submission of artwork to this exhibition will constitute agreement to the above condition. Note: the artist will wait until the end of the show to remove their art. There is a 25% commission charged on any piece sold during the show. All taxes will be the responsibility of the artist.
