## SUMMER CAMP 2020 WAIVER AND RELEASE

Although every effort is made to create a safe environment, I acknowledge that dancing is an activity which involves inherent risks. I assume risks of participating in Bronxville Ballet and waive, release and discharge Bronxville Ballet, Ana R. Dimas and any of her employees, independent contractors, third parties and any and all related parties from all liability for any damage, loss or injury arising out of my child's participation in Bronxville Ballet.

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of large groups of people.

Bronxville Ballet, Ana R. Dimas and her affiliates (collectively, "Bronxville Ballet") have put in place preventative measures to hopefully reduce the spread of COVID-19. However, Bronxville Ballet can in no way guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending camp could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending Bronxville Ballet and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Bronxville Ballet may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Bronxville Ballet, its owners, independent contractors, employees, volunteers, and program participants and their families or members of the Bronxville Women's Club or its employees, affiliates or independent contractors.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Bronxville Ballet or participation in Bronxville Ballet programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Bronxville Ballet, its employees, independent contractors, affiliated agents, and representative as well as the Bronxville Women's Club, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Bronxville Ballet, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Bronxville Ballet program. Despite my agreement to not sue Bronxville Ballet, its owner, employee(s), independent contractors, or third parties, I understand that should I still initiate a law suit(s) or any similar actions I shall be responsible to pay for all of the defendant's/defendants' costs and necessary disbursements and attorney fees plus loss of time incurred in enforcing and defending this waiver and release and recognize I may be counter-sued for damages resulting from my suit irrespective of its outcome.

There are no refunds of any kind whatsoever. I have read and understand this waiver and release and I fully understand its contents. I further understand that if my child displays any symptoms such as fever, cough, sniffles/runny nose or does not feel well they cannot attend camp and that there will be no refunds. In addition, I understand that any dancer who arrives for camp exhibiting or during camp exhibits any of the preceding signs of illness will not be allowed to participate at Bronxville Ballet's sole and absolute discretion and there will be no refund if a dancer is denied participation prior to or during class.

I hereby grant Ana R. Dimas the right the use, re-use, publish and re-publish photographic portraits or pictures of the minor or in which the minor may be included in whole or in part for the express purpose of marketing, promoting and creating the public image of her dance instruction courses and studio(s). The portraits or pictures may be used in print, electronic or web-based forms. I waive any right that I or the minor may have to inspect or approve the finished product or products. I release, discharge, and agree to have harmless any of Bronxville Ballet's photographers.

I warrant that I am of full age and have every right to contract for the minor in the above regard. I state further that I have read the above authorization, release, and agreement, prior to its execution and that I am fully familiar with the contents. This release shall be binding upon me and my heirs, legal representatives and assigns.
