BREEZEWOOD ACRES COMMUNITY ASSOCIATION, INC. Schedule of Violations and Fines and Penalties

WHEREAS, Breezewood Acres Community Association, Inc. (ASSOCIATION) is charged with establishing and enforcing Rules and Regulations, By-Laws, and the recorded Covenants, Conditions, and Restrictions governing access to and use of private lots, public and private roads and facilities, conduct of property members, guests, visitors in the development known as Breezewood Acres located in Lehigh and Dreher Townships, Wayne County State of Pennsylvania; and

WHEREAS, the Association has, from at or about its inception, drafted, prepared, amended, corrected, updated, circulated, and enforced a separate document entitled "Breezewood Acres Community Association, Inc. Schedule of Fines"; and

WHEREAS, the Association has, on or about December 10, 2022, amended, updated, reformulated, and ratified the certain and various violations and penalties for the violation of the aforementioned Rules and Regulations, By-Laws, and Covenants of Breezewood Acres Community Association, Inc., which are supported by the Declaration of Protective Covenants and Reservations and/or state, county and township laws, ordinances, rules and regulations; and

WHEREAS, consistent with the foregoing, the Schedule of Violations and Fines and Penalties are ratified, amended, authorized and approved as indicated herein as follows:

SECTION I - BACKGROUND BREEZEWOOD ACRES COMMUNITY ASSOCIATION, INC.

UNLICENSED VEHICLE REGULATIONS

- 1. All 3 and 4 wheel ATV's, golf carts, snowmobiles, motorcycles, go-carts and other unlicensed vehicles (hereinafter "Unlicensed Vehicles") must be registered in the administration office before the vehicles enter the property. All unlicensed vehicles must be registered each and every year and a copy of their insurance shall be included in the Owner's file in the office.
- 2. All operators of Unlicensed Vehicles must have a Breezewood Acres ID card which must be carried by the operator of said Unlicensed Vehicle at all times. All operators of Unlicensed Vehicles between the ages of 12-17 must obtain a Breezewood Acres ID card unless operator possesses valid license.
- 3. Your registration number (hereinafter "Plate) must be placed on the back of all Unlicensed Vehicles. Your Plate will be assigned at the time of registration.
- 4. In order to register your Unlicensed Vehicle, you must provide proof of insurance. A current copy of said insurance policy or insurance card must be in the property owner's name and be shown at the time of registration.
- 5. No person under the age of 12 is permitted to drive an Unlicensed Vehicle.
- 6. No Unlicensed Vehicle, with the exception of snowmobiles equipped with proper lights, shall be driven from the hours of 8 p.m. through 8 a.m. from November 1 to March 31. No Unlicensed Vehicle shall operate during the period of 8 p.m. through 8 a.m. from April 1 to October 31. Exception: Operators 18 years of age and over may operate Unlicensed Vehicle between the hours of 8 a.m. and 10 p.m.. No Unlicensed Vehicle shall operate after sunset, except golf carts equipped with proper lights on the front and rear of the Unlicensed Vehicle.
- 7. All Vehicles must follow the speed limits within the Association. These speed limits are 15 mph on Geronimo Drive and 10 mph on all other glen roads.
- 8. All Vehicles will obey all stop signs and any other street signs within the campground.
- 9. All Unlicensed Vehicles must, at all times, have mufflers installed. These mufflers will be checked and must be at or under a 90-decibel discharge.
- 10. At no time shall any Vehicle be driven or ridden in an unsafe or reckless manner.

- 11. All Security Officers have the right to stop any Unlicensed Vehicle at any time and check to insure the proper registration, insurance and ID card.
- 12. D.O.T. approved helmets are to be worn by the driver and passenger of any Unlicensed Vehicle, except golf carts.
- 13. Go-carts must have a 60 inch long safety flag whips and orange or red reflector tags attached to it.
- 14. The number of passengers on an Unlicensed Vehicle shall not exceed manufacturers specifications. All occupants must be seated at all times.
- 15. There will be no storage of vehicles over 30 days in a 365 day period.
- 16. All Unlicensed Vehicles must be no more than 1000cc's.
- 17. All snowmobiles must be registered.

ARTICLE IV - ENFORCEMENT OF PENALTIES AND VIOLATIONS

- 401. Any fines and/or penalties imposed via a citation issued, either in person or by mail, shall automatically be added to the account of the Property Owner named on the citation absent a request for a hearing before the Breezewood Acres Community Association Court. If you are convicted of such violation, a \$25.00 fee along with the fine(s) for the violation(s), and reimbursement of all costs, fees and expenses incurred by Breezewood Acres Community Association including but not limited to reimbursement of personnel costs when personnel's attendance at hearing is required, certified mailing fees, etc., will be added to your account.
- 402. Any request for a hearing before the Association Court shall be made, in writing, within fifteen (15) days of the date of the citation.
- 403. Failure to request such a hearing shall constitute a waiver of the opportunity to have such a hearing and automatic imposition of the fine to the account of the Property Owner.
- 404. Any hearings provided for herein shall be scheduled at the direction of the Association Court.
- 405. Failure to appear at any hearing scheduled hereunder shall constitute a conviction of the violation(s) charged and the fine(s) imposed therein shall be automatically charged to the account of the Property Owner and will be treated in the same manner as being convicted of the violation.
- 406. Any Property Owner aggrieved by the disposition of the Association Court shall have the right to request a hearing before the Board of Directors. However, the granting of such a hearing shall be at the Board of Directors' sole and exclusive direction.
- 407. Chronic and repeat violators of any of the provisions herein shall be subject to revocation of use of common areas, use of recreational facilities (golf carts, motorcycles, ATV's and similar vehicles) at the discretion of the Board of Directors.
- 408. A third or subsequent conviction of any violation provided for herein shall require a sanction hearing before the Board of Directors.

- 409. Enforcement of any and all violations and/or penalties provided for herein shall also carry with it any and all costs, fees, expenses, expert fees, legal fees, filing costs and/or similar or related expenditures incurred by the Association relative to the enforcement of the same.
- 410. In addition to any and all other penalties and enforcement provisions provided for herein, the Association shall also have the right and power to see any and all remedial and/or equitable relief in the Court of Common Pleas of Wayne County, Pennsylvania.
- 411. This Schedule of violations, penalties, fines, sanctions, and enforcement provisions may be amended by the Board of Directors at any regular or special meeting of the Board of Directors.
- 412. The duly appointed members of the Breezewood Acres Community Association Security/Public Safety staff are hereby authorized to and shall have full and complete power to enforce any and all of the provisions hereunder.
- 413. Definitions of any of the violations included herein shall, if applicable, follow the same definition found for such violations under the Pennsylvania Vehicle Code or Pennsylvania Crimes Code.

ARTICLE V - ADOPTION
