

Dear Fellow Optician,

As you know, our licenses will expire on December 31, 2020. As you also probably know, by Board rule a maximum of five of the twenty required CE hours are allowed to be taken as out-of-clasroom hours.

Despite the fact that I have petitoned the Board of Opticianry to allow for all out-ofclassroom hours for at least this biennium, they have failed to act. I have also petitioned the Governor to extend the renewal period, but he has yet to do so.

Therefore, I had to make a decision to present our live seminars or not. I postponed three events that were originally scheduled for March and April, but decided to resume them beginning with our Gainesville seminar that was held on May 17. All our attendees and instructors wore masks, maintained social distancing as much as possible, and everyone treated one another with respect and consideration. We will be holding our seminars in meeting rooms that are designed to hold twice the expected attendance, and sit in chairs. No tables.

Moving forward and until further notice, all attendees will be required to:

- Sign the affidavit regarding symptoms and the waiver of liability forms which appear below. Please print them and fill them out and bring with you the morning of the seminar. If you do not have the capacity to print them, blank forms will be available at the door.
- Have his/her temerature taken prior to admittance. Anyone with a temperature above 99.8° F will not be admitted.
- Wear masks in the seminar room.
- Maintain social distancing.
- If you cannot adhere to the above requirements, or if you would be more comfortable attending an event later in the renewal period anywhere in the state, the fees you paid to attend will be applied to a future event.
