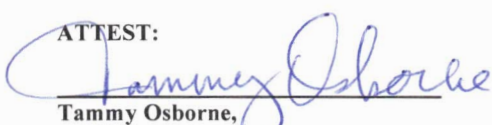
Motion was made by Councilmember Weger to accept the resolution as presented, second was made by Mayor Douglas. Motion prevailed by the following vote:

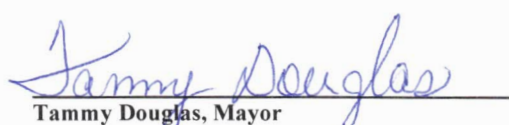

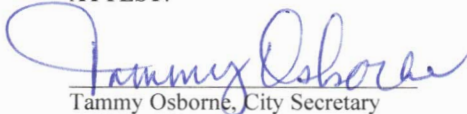

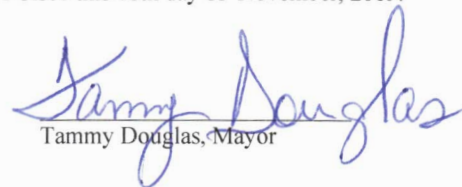
IT IS FURTHER FOUND AND DETERMINED that the results of the election as tabulated in the preamble hereof reflect the expressed desires of those persons voting at said election.
