Meeting of the DeKalb County Commission

Presiding Commissioner, Harold Allison, East District Commissioner, Garry McFee, West District Commissioner Kyle White and County Clerk, Melissa Meek.

Presiding Commissioner, Harold Allison led all in attendance in prayer with all reciting the Pledge of Allegiance.

East District Commissioner, Garry McFee made the motion to accept the agenda as presented and approve the minutes for the March 12, 2018 meeting. West District Commissioner, Kyle White made the second. Motion carried.

The County would like to thank the Maysville Baptist Church for their kindness and generosity for hosting a meal for all County and City Employees.

Accounts payable were reviewed and approved.

Mowing bids were opened at 10 a.m. with Rogers Outdoor Services being awarded the bid for Old Maysville Cemetery and Bobbi's Transport and Lawn Care being awarded Smith Cemetery, Shuchman Cemetery, The Fairgrounds and the County Barn. All bidders provided current proof of insurance.

Presiding Commissioner, Harold Allison announced the electronic pick-up for the County for Region D Recycling would be April 28th between the hours of 1-5.

Road & Bridge Supervisor, Bill Gray met with the Commission to discuss equipment, tires and the ability to purchase a new welder which was approved by the Commission. He has also asked that the Clerk obtain a bid for 2" surface rock from Norris.

Assessor Tanya Zimmerman met with the Commission to discuss donating her computers to an entity in need. They approved her request.

Lisa Bird acting FFA Advisor for this day brought a group of FFA youth to do a presentation on Ag Issues. The group did a fantastic job presenting in front of the Commission and Clerk. Those in attendance were Connor Flinn, Jordan Browning, Grace Hamby, Cole Gripka, Braden Covey as well as Mrs. Bird. The Commission thanks Brandi Ellis for all of her hard work in her capacity as AG Instructor here at the Maysville School District.

The Commission reminds everyone that the Sales Tax Rock issue on the ballot is not a new tax but yet a continuation tax for rock on our County roads. With these funds the Commission is able to apply 120 tons to the mile on the gravel roads in our County.

The Commission gave an update on the meeting that was had in Cameron on the 16th of March with the Director of MODOT and other officials concerning the I-35 and 36 interchange. They all see the need in the work that needs to be done but funding is an issue. Some are looking at making the area a TDD and that would allow the patrons doing business within that district to pay a tax that would go into a fund that would allow the work to be done on the interchange. More discussion will be had on the issue with more updates to come.

East District Commissioner, Garry McFee made the motion to adjourn with Presiding Commissioner, Harold Allison made the second. Motion carried.
