"Resolved, that the Association is hereby authorized to and approves JOHN BAKER ("Guarantor") as the personal guarantor for a credit card for the Association; and,

Resolved, the credit card and Guarantor's agreement to personally guarantee same is reasonably expected to benefit, directly or indirectly, the Association; and,

Resolved, the Association warrants and agrees that it will pay the full balance owed for the credit card each month on time; and,

Resolved, should the Association fail to timely issue payment, Guarantor may do so. Any sums paid by Guarantor due to failure to pay by the Association will be secured by a Note which includes late fees and interest levied by the credit card company; and,

Resolved, the Association shall be the primary party liable for the credit card and shall reimburse and make whole Guarantor from any cost fees, or penalties incurred due to the

Association's failure to issue timely payment, such sums to be supported by a Note or other agreement entered into by the Association and Guarantor in connection with the credit card; and,

Resolved, that the Director of the Association (the said officer or combination of officers being hereinafter referred to as the "Designated Officer" whether one or more) be, and the Designated Officer is hereby authorized for, in the name of, and on behalf of the Association to execute, attest, acknowledge and deliver this Resolution and a Note, if needed, and such other documents as the Designated Officer shall approve, the execution and delivery of such documents to be conclusive evidence of such approval; and,

"Resolved, that the Director of the Association is hereby authorized and directed to certify these resolutions to Guarantor; and,

"Resolved that the Designated Officer is hereby authorized and directed to do all other acts and things as may be required to carry out, perform, and give effect upon the part of the Association to the terms and provisions of these Resolutions and the aforesaid documents."
