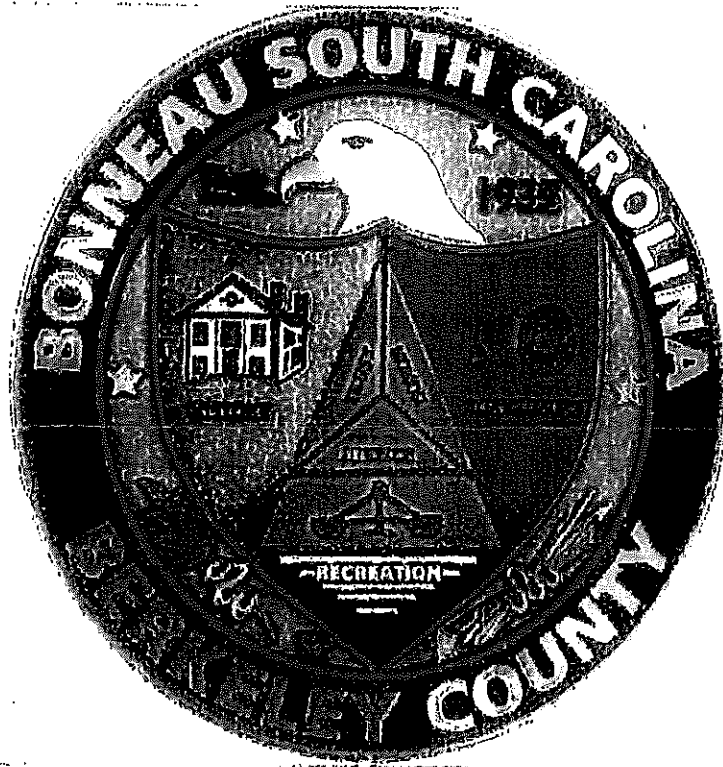

Business License Ordinance

ORDINANCE NO. 71
TOWN OF BONNEAU, BONNEAU SC

AN ORDINANCE TO AMEND THE BUSINESS LICENSE ORDINANCE OF THE TOWN OF
BONNEAU.

It is hereby ordained by the Mayor and Council of the Town of Bonneau, South Carolina, that:

The Business License Ordinance of the Town of Bonneau, South Carolina, is hereby changed to read:

SECTION 1:

LICENSE REQUIRED PAYABLE BY JANUARY 31ST ANNUALLY.

Every person who engages in or who may engage in any calling, business, trade, occupation or profession, in whole or in part, within the corporate limits of the Town of Bonneau, South Carolina, is hereby required to pay an annual license fee and obtain a business license therefore prior to January 31st of each year as herein provide.

The license fee shall be paid for each business subject hereto according to the applicable rate classification or before January 31st in each year. A separate license shall be required for each place of business and for each classification of business conducted at one place; provide, however, all classification of business conducted at one place, may be licensed, at the option of the Town Clerk, unless a single license calculated at the primary rate for each classification. The primary rate shall be applied to each business. If gross income cannot be separated for classification at one location, the license fee shall be computed on the combined gross income for classification requiring the highest rate.

A license fee based on gross income shall be computed on the gross income for the preceding calendar or fiscal year and on a twelve month projected income based on the monthly average for a business in operation for less than one year. The fee for a new business shall be computed on the estimated probable gross income stated in the license application for the balance of the calendar year by the Town Clerk. No fractional parts of license shall be granted.

SECTION 2:

OFFICIAL APPLICATION FORM TO BE FURNISHED BY THE TOWN.

The owner, agent or legal representative of every business subject to this ordinance shall register the business and make application for a business license on or before January 31st of each year. A new business shall be required to have a business license prior to operation. Application form shall be provided by the Town. It shall contain the social security number or federal employee's identification number and all information about the applicant and the business deemed necessary to carry out this provisions and purposes of this ordinance by the Mayor and Council. The applicant shall certify that all information given in the application is true.

AN ORDINANCE TO AMEND THE BUSINESS LICENSE ORDINANCE OF THE TOWN OF BONNEAU TO MODIFY THE RATE STRUCTURE

IT IS HEREBY ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF BONNEAU, SOUTH CAROLINA, THAT:

SECTION 4: RATE SCHEDULE

WHEN AMENDED, THIS SECTION SHALL READ AS FOLLOWS:

The license fee for all business, trades, occupations, professions or activities required by this ordinance shall vary with the several levels of income categorized below to reflect a fair and progressive method of assessment for business license purposes, pursuant to South Carolina law.

The following scale shall apply to all persons, firms or corporations required to obtain a license in the Town Of Bonneau South Carolina

<u>GROSS BUSINESS OF</u>	<u>LICENSE TAX</u>
\$ 0 - 5,000	\$ 50.00
5,001 - 10,000	80.00
10,001 - 15,000	110.00
15,001 - 25,000	140.00
25,001 - 50,000	170.00
50,001 - 100,000	208.00
100,001 - 200,000	245.00
200,001 - 300,000	320.00

For gross business in excess of \$300,000 and up to and including \$800,000, the amount of \$350.00 plus an additional fee of \$1.00 for each additional \$1,000 or fraction thereof shall be charged on all over \$300,000.

For gross business in excess of \$800,00, the amount of \$450.00 plus and additional fee of \$0.10 for each additional \$1,000.00 or fraction thereof shall be charged on all over \$800,00.

This ordinance shall take effect and be in full force after its passage according to the law.

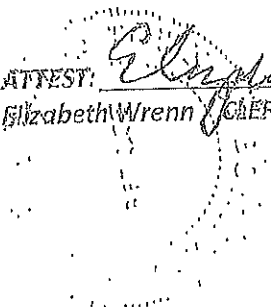

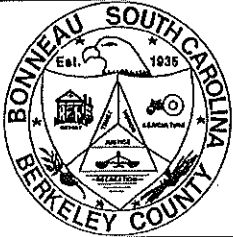
