In understanding and agreeing to this contract, the breeder/seller and the buyer/own agree to the following terms and conditions. Herein, the buyer will be referred to as owner/buyer, and the breeder will be referred to as the breeder/seller.		
(owner, buyer)(secondary owner) will be listed as the owner(s). Lagotto Romagnolo of House Woller will be listed as breeder on any registration and advertising.		
It has been explained to the buyer by the breeder that purchasing a young lagotto for companion and/or performance purposes is a measured risk, and that the breeder has in good faith evaluated this lagotto to the best of their ability. There are no guarantees with regards to the lagotto's ability to perform in the show/ring, performance ring, as a service or therapy animal.		
Companion animals are from parents with sound temperaments, however, environmental factors and training all play a role in the temperament of the lagotto as they grow. House Woller makes no guarantee regarding temperament except where temperament is deemed hereditary. All puppies born at House Woller are progeny of parents who are OFA, and DNA tested.

Health Warranty

House Woller is committed to warranting our puppies for hereditary, congenital and/or genetic conditions.

We do not warranty any of the following:

- Physical conditions that your lagotto displays that is a result of an injury
- Emotional reactions as a result of an injury
- Secondary medical, emotional or physical conditions that result from an injury
- Unforeseen illness that results from bacterium or virus contracted off House Woller property
- Injury or illness that is a result of pet food
- Injury of illness that is a result of a vaccine reaction.

The buyer agrees to keep their lagotto at a healthy weight (weight is outlined per the AKC breed standard). If the lagotto is found to be overweight at the time of any health issue that is subject to the warranty, the health warranty is void and House Woller is released from all liability regarding all medication conditions of the lagotto sold.

HIPS: Your lagotto, regardless of "classification type" is warranted for HIP DYSPLASIA until they are 3 years old. If this lagotto is found to have hip dysplasia, by proof of 1 (one) unpassing OFA report and 1 (one) PennHip report, at the buyers expense, after the age of 2 (two) years old and before the age of 3 (three) years old, one thousand dollars US (\$1000.00) of the purchase price will be refunded should buyer wish to keep the lagotto AND the lagotto is found to be of proper weight (proof of vet records must be provided to the breeder directly from the vet). The hip warranty is void if the lagotto is overweight as per the American breed standard at the time of testing.

Should buyer wish to have a suitable replacement, a lagotto of similar characteristic and quality (same sex and similar value) will be granted in lieu of a refund under the following conditions:

Your lagotto is warranted for idiopathic seizures directly related to junior/juvenile epilepsy (BFJE) for the first year that they are with you. This condition, (BFJE), is known in the lagotto breed and has, to the best of the breeder's ability, been bred out of your lagotto. Should the lagotto have a seizure, the buyer agrees to genetically test the lagotto for BFJE. If the lagotto tests BFJE positive, House Woller will reimburse the buyer the cost of the BFJE testing.

If the lagotto is BFJE positive, and the treating veterinarian feels this condition will limit the lagotto's life and the buyer wishes to keep their lagotto, the buyer has the option of a refund of one thousand dollars US (\$1000.00). Once the buyer selects this option, no further warranty can be claimed on this lagotto in this section (seizures).

Should the buyer wish to have a suitable replacement lagotto, a lagotto of similar characteristic and value (same sex and similar value) will be granted in lieu of the refund under the following conditions:

- 1.) Return of the lagotto testing positive for BFJE to seller at buyer's expense,
- 2.) The buyer has provided proof of euthanasia (euthanasia is only an option if a veterinarian documents the necessity and breeder concurs.)

A replacement animal must be selected from one of the first two litters produced by House Woller after it has been determined that a replacement is necessary. Should the buyer fail to engage in the CERF evaluation, this section of the warranty is void.

Reactive Seizures

Reactive seizures are caused by the brain's reaction to an environmental, metabolic problem or reaction to a toxin (i.e., low blood sugar, medication, vaccine or a toxin).

Your lagotto is not warrantied for reactive seizures. It is your responsibility to keep your lagotto safe once it leaves House Woller. At no time, shall your lagotto be given Ivomectin or Heartgard due to the potential breed sensitivity even with negative parental DNA testing. Using such product voids any/all seizure guarantee and the entire health warranty of the puppy (see lagotto sensitivity section).

Secondary Seizures

Secondary seizures are the result of a brain tumor, stroke, or trauma. Brain tumors in your lagotto are warranted until your lagotto is 1 (one) year old. Stroke is covered on a case by case basis until your lagotto is 1 (one) year old. Your lagotto is not warranted for seizures related to trauma, toxin, vaccine reactions, bacteria, and/or viral infections.

Because secondary seizures are caused by several reasons, House Woller reserves the right to have the lagotto's medical records sent to House Woller farm for review by our veterinarian and have the lagotto examined by an independent veterinarian. Such an exams/reviews/consultation will be at the seller's expense.

Should the lagotto have a condition that is deemed genetic in nature, but not yet testable, the buyer has the option of a refund of one thousand dollars US (\$1000.00) of the purchase price if the buyer wishes to keep the lagotto. Once the buyer opts this option, no further warranty can be claimed on this lagotto in this section (seizures).

Should the buyer wish to have a suitable replacement lagotto, a lagotto of similar characteristic and value (same sex and similar value) will be granted in lieu of the refund under the following conditions:

- 1.) Return of the lagotto with the secondary seizure problem to seller at buyer's expense,
- 2.) The buyer has provided proof of euthanasia (euthanasia is only an option if a veterinarian documents the necessity and breeder concurs.)

A replacement animal must be selected from one of the first two litters produced by House Woller after it has been determined that a replacement is necessary. Should the condition onset directly after the administration of vaccines this section is void.

Cerebellar Abiotrophy:

Cerebellar abiotrophy is a very rare, genetic neurologic disease that affects certain canine breeds, including Lagotto. This problem starts in early puppyhood, with affected puppy beginning to show symptoms between the ages of 6 and 16 weeks. This disorder causes affected dogs to have difficulty keeping balance and controlling their movements. They become clumsy, have difficulty walking and can have consistent tremors.

There is no treatment or cure for this condition. This is a degenerative and progressive disease that lowers the quality of life in most dogs. There is no known genetic testing for this condition, although there is research currently being conducted. Should your lagotto show signs of cerebellar abiotrophy, and this condition is confirmed by a canine neurologist, you have the choice to be refunded for your lagotto or have a replacement lagotto. If your lagotto develops any signs of this condition it is essential that you let us know immediately, as we will no longer breed the parent cross. We will do whatever is in our power to assist in healing your puppy.

Should the buyer wish to have a suitable replacement lagotto, a lagotto of similar characteristic and value (same sex and similar value) will be granted in lieu of the refund under the following conditions:

Should the buyer wish to have a suitable replacement lagotto, a lagotto of similar characteristic and value (same sex and similar value) will be granted in lieu of the refund under the following conditions:

- 1.) Return of the lagotto with the cerebellar abiotrophy problem to seller at buyer's expense
- 2.) The buyer has provided proof of euthanasia (euthanasia is only an option if a veterinarian documents the necessity and breeder concurs.)

A replacement animal must be selected from one of the first two litters produced by House Woller after it has been determined that a replacement is necessary. Should the condition onset directly after the administration of vaccines this section is void.

There is no warranty for this condition after your lagotto is two years old (twenty-four months).

ENDROCRINE CONDITIONSLysosomal Storage Disease

Lysosomal storage disease, Lagotto Romagnolo type, (LSD) is one form of wider group of metabolic disorders known as Lysosomal Storage Diseases (LDSs) which is known to affect humans, lagotti, cats and mice. LSD is a fatal disease. House Woller, Inc. does breed canines who are known carriers. LSA is warranted until the age of 5.

Your lagotto is free from the LSD gene through parentage genome. The LSA status of this lagotto is <u>negative</u>. This LSA status has been verified by DNA testing of both parents (see DNA section of puppy book). Should your lagotto show symptoms of LSD, the buyer agrees to genetically test the lagotto for LSD. If the lagotto tests LSD positive, House Woller will reimburse the buyer the cost of the LSD testing.

LSD is a fatal condition. The buyer may choose to have a refund for the sale price of their lagotto. Should the buyer wish to have a suitable replacement lagotto, a lagotto of similar characteristic and value (same sex and similar value) will be granted in lieu of the refund under the following conditions:

1.) The buyer has provided proof of euthanasia to the seller as LSA is a fatal condition.

<u>LAGOTTO SENSITIVITY</u> Medication

Lagotti are ancient rare breed dogs. At no time shall said lagotto be given **Ivermectin or Lotilaner any medication made is an Ivermectin or Lotilaner derivative.** No products made by Heartgard shall be given to your lagotto including Nexgard, Tri-heart, or Iverheart due to the potential breed sensitivity. Proheart 6 and/or 12 is never to be given to your lagotto. Nextgard, Simparica, Credilio and revolution plus can not be used. Using such product voids any warranty on your pet regardless of the reason for use. We recommend using Sentinel or Interceptor. Use Trifexis with extreme caution.

** We do not warranty medical conditions that are a result of a medication reaction. **

Food

At no time shall the buyer feed their lagotto a "raw" diet. This is due to the risk of salmonella exposure and/or other bacteria that can harm your lagotto.

At no time shall the buyer give their lagotto "fish" flavored dog food or any type of dog food with any type of "fish/ocean" meal or any form of ethoxyquin as an ingredient/ preservative written on the food label or used as a secondary ingredient which is not labeled.

This includes any prescription foods prescribed by a Veterinarian. The purchaser understands that feeding their Lagotto any type of "fish" flavored food, or "fish meal" will immediately void all warranties included in this agreement.

It is the buyers responsibly to provide Lagotto of House Woller records of food purchased should this part of the health warranty be in question.

Lagotto Romagnolo of House Woller recommends that our puppy parents feed a combination of grain and grain free food. Doing so reduces the risk of a food related injury to your lagotto.

Buyers are given instruction in the feeding schedule/diet of said lagotto and should consult House Woller for dietary changes, questions, etc.

Vaccines

Leptospirosis and Lyme - The buyer agrees to not permit vaccines for leptospirosis and lyme to be given to their lagotto on the same day. If they are to be given they are to be given minimally 4 weeks apart from one another. Additionally these two vaccines are not to be given on the day that any other vaccines are given. These two vaccines can have potential side effects and need to be given only when the risk of the illness outweighs the risk of the vaccine.

Vaccine combinations over "6 ways" are not permitted to be used on your puppy.

** House Woller does not warranty heath complications that are a result of vaccine reactions**

SHOW/BREEDING ADDITIONAL HEALTH WARRANTY ADDENDUM

Purchasing a young lagotto for show purposes is a risk, and that although the breeder has, in good faith, evaluated this lagotto to the best of their ability, House Woller, Inc. cannot guarantee the future success of this lagotto in the show ring.

At times, breeders and owners agree to show and enter their lagotto into the breeding/stud program. Should that occur after the fact, verbally or in writing, on a lagotto that was originally sold as a companion, all the companion clauses listed above apply along with the following addendum.

DNA:

Prior to breeding the buyer will have the lagotto fully DNA tested in order to determine the DNA compatibility of this lagotto with others. DNA testing may occur through any of the DNA testing companies that are able to link with OFA and/or endorsed by the American Kennel Club.

EYES:

Should the lagotto test positive for a genetic eye condition, prior to breeding the buyer will have the eyes of the lagotto examined an CERF or OFA certified by a qualified veterinary ophthalmologist for the condition. If this lagotto is found to have a hereditary eye defect as indicated by 2 (two) un-passing eye exams by a certified veterinary ophthalmologist, rendering this lagotto unsuitable for breeding the following applies:

The buyer will provide House Woller with written proof by a certified canine ophthalmologist that the lagotto is not a breeding candidate due to a specific genetic eye condition. The lagotto has been spayed or neutered. The breeding contract for both parties is then fulfilled.

Should the buyer wish to have a suitable replacement, a lagotto of similar characteristic and quality (same sex and similar value), will be granted under the following conditions:

- A.) return lagotto to seller at buyer's expense
- B.) proof of euthanasia (euthanasia is only an option if a veterinarian documents the necessity and breeder concurs.)

Should the buyer wish to keep the lagotto, the lagotto will be spayed/ neutered and the co-own clauses and SHOW/BREEDING ADDENDUM clauses within this contract are terminated. All the companion warranty and clauses are still effective at

that time. This warranty shall be in effect until the lagotto reaches the age of three (3) years, or until the lagotto is bred. If the option of obtaining a replacement animal is executed by the buyer, the replacement must be selected from one of the first two litters produced by House Woller after it has been determined that a replacement necessary.

BITE:

If this lagotto's bite is undershot or overshot with a satisfactory inspection by the breeder or the buyer has a signed statement by a licensed veterinarian, of such bite issue, the buyer has the following options: retain a new show canine

The buyer may request a new show animal if the lagotto purchased has been returned to House Woller. Should the buyer wish to have a suitable replacement, a lagotto of similar characteristic and quality (same sex and similar value) will be granted if: The lagotto is returned to House Woller at the buyer's expense. If the replacement animal has been selected, a replacement animal must be selected from one of the first two litters produced by House Woller after it has been determined that a replacement is necessary.

Should the buyer wish to keep the said lagotto, the lagotto will be spayed/ neutered and the co-own clauses and SHOW/BREEDING ADDENDUM clauses within this contract are released. All the companion animal warranty and clauses continue to be effective. There will be NO refund for conditions related to bite.

CRYPTORCHIDISM:

The testicles of this lagotto and this lagotto's sire have been examined by a qualified veterinarian and found to be clear of all abnormalities. If this lagotto is found to have a defect rendering it unsuitable for breeding (non-mobility of semen), by a reproductive veterinarian, and the buyer wishes to keep the said lagotto, the lagotto will be neutered. The co-own clauses and SHOW/BREEDING ADDENDUM clauses within this contract are canceled. All the companion warranty and clauses become effective. There is no refund option as to this condition.

Should the buyer wish to have a suitable replacement, a lagotto of similar characteristic and quality (same sex and similar value) will be granted in lieu of the refund under the following conditions: return lagotto to seller at buyer's expense.

This warranty shall be in effect until the lagotto reaches the age of three (3) years, or until the lagotto is bred. A replacement animal must be selected from one of the first two litters produced by House Woller after it has been determined that a replacement is necessary.

TEMPERAMENT:

Temperament is warranteed until the puppy is 18 months old. If the puppy has endured any type of trauma, intentional or unintentional, after the sale of the lagotto and during the first 18 months of the puppies life the temperament warranty is void.

Trauma is defined as any unplanned and/or sudden change in the puppies life that has disrupted its natural ability to mature, in a manner consistent with the intention that the puppy was sold under.

This puppy was temperament assessed by the breeder at 7 weeks old using the Volhard method. The temperament test results of this lagotto were provided to the buyer. The buyer agrees to begin the lagotto in lagotto private training with a qualified trainer by the age of 16 weeks or in the case of group training class, upon titer results, and will continue training until they have completed the canine good dog citizen certificate. All training and socialization sections of this contract should be met.

Should a temperament issue arise, such cases shall be reviewed on a case by case basis with the breeder, a veterinary examination (inclusive of a neurological evaluation), and certified lagotto trainer (where necessary in temperament cases).

Once all these professionals have consulted with House Woller replacement/refund options will be provided to the buyer. The sellers decision on this issue is final. If the lagotto was not in a recognized training program with a certified dog trainer, starting at age 12-16 weeks, reaching canine good citizen status, no refund will be issued.

If the buyer feels that the lagotto cannot be managed by them in their home and they are citing a temperament issue, the lagotto will be returned to House Woller for assessment and potential training. This section of the warranty will be inactive once the lagotto reaches 18 months old.

Traveling Home from House Woller

The buyer agrees to NOT allow their new lagotto to potty in any highway or airport terminal "potty spots". This includes rest areas or grassy areas along the interstate where dogs will frequently potty. These areas are potential "hot spots" for illnesses, some potentially fatal illnesses, such as parvovirus and/or distemper, bordetella, and/or the canine flu. They also potentially contain parasites such as giardia, coccidia, fleas and ticks. During transport home, the buyer agrees to use a potty pad for their lagotto to relieve themselves on. (See HOW addendum 2 for more).

Vet visit within 72 hours

Should the buyers licensed veterinarian examine the lagotto within the 72-hour period and find any signs of contagious disease, heart murmurs or inherited abnormalities, the purchaser has the option to return the lagotto to Lagotto Romagnolo of House Woller provided it has no other problems other than those present at the time of sale.

If there are problems found with your lagotto it must be returned to House Woller within 36 hours of the problem being discovered and must not have been exposed to any other contagious diseases within that time frame. Upon return of the lagotto, and after receiving written proof from the examining veterinarian of the lagotto's problems, purchaser shall be offered a full refund of purchase price.

Some internal parasites can be bought on the stress of the puppy moving. In the case of internal parasites, the buyer has the option to return their puppy to House Woller or have the medication for parasite treatment reimbursed by House Woller. House Woller, Inc. will not pay for initial test, retesting or office visits with regards to an internal parasitic issue.

It is agreed to and understood that the purchaser is responsible for all veterinary bills incurred while the lagotto is in his/her/their possession and for all transportation costs back to the seller. The buyer understands that not having the lagotto examined by a licensed veterinarian within 72 hours of the lagotto leaving House Woller voids this section of the warranty.

This Warranty/Agreement is Non-Transferable.

House Woller Surname

All puppies bred by HOUSE WOLLER, INC., will carry only the "HOUSE WOLLER" farm name on the registration certificates. HOUSE WOLLER, Inc., is a professional show kennel and lagotto farm. HOUSE WOLLER registers all their puppies in conjunction with the theme of the litter. This includes any puppies owed back on co-ownership agreements.

Registration

All puppies are registered with the AKC by HOUSE WOLLER at HOUSE WOLLER's expense prior to the puppy leaving the House Woller premises. The Buyer understands that their lagotto will be registered with the "House Woller" farm/show name. The buyer is free to change the "call name" of the lagotto and call the lagotto whatever they choose.

Lagotti sold as companion/performance/working will be registered with a "limited" AKC registration to protect the pedigree of this lagotto. Limited Registration means that the lagotto is AKC registered but that any litters produced by that lagotto, in the future, are not eligible for registration. Limited registration also restricts the lagotto's ability to compete in conformation shows. The AKC "Limited" registration designation can be removed from the AKC registration with the Seller's permission. Removing the "limited" status, allowed the lagotto to both enter conformation shows and register litters.

Your lagotto is eligible, to be entered in any other type of AKC events including, Obedience, Tracking, Field Trials, Hunting Tests, Herding, Lure Coursing, Agility and Earth dog.

Copies of the registration papers, will be provided to the seller, upon receipt from the AKC. The buyer will receive at the time of sale a copy of the registration information and puppy's AKC registration number.

Breeding Rights

If this lagotto is being sold as a companion or performance lagotto it is agreed tha
this lagotto will not be used for breeding purposes. Should the buyer and House
Woller at some point, after the execution of this contract, agree verbally or in writing,
that this lagotto will be used as a breeding/show lagotto then the breeding/show
addendums shall be in full force and this lagotto will be considered "co-owned" unti
the addendums are fulfilled

Health

The buyer will be responsible for all costs incurred under normal lagotto ownership, including yearly/biyearly pet exams, health certification costs, DNA testing costs, CERF/OFG Certifications.

Additionally, routine and emergency veterinary care are the responsibility of the buyer. For the HIP warranty to be in effect, an OFA must be attained between the ages of 24 and 36 months old.

For the EYES warranty to be in effect a CERF must be completed biannually up to 3 years old. The buyer also agrees to bear all costs of transportation, x-ray exams, and veterinary costs relating to the sale or replacement of the above lagotto. Should the buyer elect to NOT have their lagotto OFA'd or CERF'd per this outlined agreement, the terms of this agreement regarding that specific part of the warranty become null and void.

Continued Health Care

it is the buyer's responsibility to provide the lagotto with continued core vaccines, routine health care and a safe living environment. Puppies shall be minimally vaccinated against Rabies, Adenovirus, Parainfluenza, Distemper and ParvoVirus.

This puppy has been nomographed the by Dr. Laurie Larson at the University of Wisconsin. The buyer agrees to provide the nomograph to their treating vet and to encourage the vet to follow the vaccine schedule that Dr. Larson has outlined for both parvovirus and distemper.

The seller agrees to titer test the puppy through the University of Wisconsin at the recommended week outlined by the nomograph. Due to the small possibility of vaccine failure the seller agrees to not take their puppy to any area where there is a high concentration of dog feces (high traffic area) until a titer has been completed.

This includes the dog park, dog walking areas, and/or any place where dogs have defected or congregate.

The buyer agrees to not permit vaccines for leptospirosis and lyme to be given to their lagotto on the same day. They agree to never authorize these vaccines within 4 weeks of one another. Additionally these two vaccines are not to be given on the day that with any other vaccines are given. These two vaccines can have potential side effects and need to be given only when the risk of the illness outweighs the risk of the vaccine. Lagotto puppies are not to be given combination vaccines over 6 ways.

<u>Titer Testing</u> The buyer agrees to have the lagotto titer tested for distemper and parvo through

be forwarded to Dr. Woller for review and research purposes. The forms and instructions for such testing are included in this contract.

Training, Socialization and Temperament

Temperament is warrantied until the puppy is 18 months old. If the puppy has endured any type of trauma after the sale of the lagotto and/or during the first 18 months of the puppy's life, intentional or unintentional, the temperament warranty is void. This puppy was temperament assessed at 7 weeks old using the Volhard method. The temperament test results of this lagotto were provided to the buyer. Your lagotto have been placed with you based upon the outcome of this assessment.

Companion animal buyers agree to the proper training and socialization of their lagotto regarding obedience, house breaking, etc. Socialization training should begin after the completion of lagotto puppy vaccines and titer (age, week 17) and should continue minimally through intermediate obedience. Companion animals that have been sold as therapy/service animals will be trained through advanced obedience training and will obtain the canine "good citizen" designation through the AKC.

Companion animals that are not trained and/or properly socialized and are presenting with temperament issues will be evaluated by House Woller and/or the seller's veterinarian and trainer. If the canine did not complete a training program with a certified canine trainer during weeks 16 to 32 of the lagotto's life, with a certificate of completion, this section of the agreement is void.

Should a temperament issue arise within the first 18 months of the lagotto's life, such cases shall be reviewed on a case by case basis with the breeder, a veterinary examination (inclusive of a neurological evaluation), a vaccine review, and certified lagotto trainer (where necessary in temperament cases). Once all these professionals have consulted with House Woller, replacement/refund options will be provided to the buyer. Should the seller opt to refund the buyer and the buyer wishes to keep the said dog, refund will not exceed 1/4 of the selling price of the lagotto minus the deposit. The sellers decision on this issue is final.

If the buyer feels that the lagotto cannot be managed by them in their home citing a temperament issue, the lagotto will be returned to House Woller for assessment and potential training. There is no guarantee as to the return of the lagotto once House Woller, Inc. takes possession.

Return of Lagotto

Buyer agrees that if, for any reason the Buyer cannot keep their lagotto, the lagotto will be returned to Seller.

Return of Newly purchased puppy

You may return your lagotto to HOUSE WOLLER within 72 hours of taking possession of the puppy for a full refund minus your reservation fee. After the 72 hour period and up to 30 days after the sale of the lagotto, refunds for a returned lagotto will be granted at the Seller's discretion only.

If the buyer is requesting a refund, a refund request form must be sent to the seller within 24 hours of the lagotto being returned to HOUSE WOLLER. Should a refund be considered, and approved by HOUSE WOLLER, the refund will not exceed ¼ of the lagotto's purchase price. The Buyer assumes all costs in transporting lagotto back to Seller.

Refunds will not occur after 30 days of the buyer owning the lagotto. In the instance of a return, House Woller agrees to take the lagotto to the vet within 72 hours of receiving the lagotto to ensure that the lagotto is free of any medical conditions. If the lagotto is found to have any medical conditions, the buyer is responsible for the medical and rehabilitation costs as it relates to the medical condition of the lagotto.

Active deployment

If, in the case of an active military family, the buyer is deployed overseas and needs to temporary rehome there lagotto the buyer will notify the seller. The rehome will need to be approved by House Woller in order to ensure the needs of the lagotto are being met.

Surrender to a shelter, rescue, pound, resold or rehomed

This lagotto is never to be placed in a shelter, rescue organization, pound, re-sold or re-homed without written consent of Seller. There are no acceptations to this policy. Liquidation damages of an "rehoming/surrender" breach will be the total sum of the original price of the lagotto, \$3990.00 + \$5000.00, and the cost of the breeder's legal fees. This means that if a House Woller lagotto is ever found to be rehomed, placed in a shelter, rescue organization, pound or re-sold without written consent of Seller this clause takes effect.

Humane Treatment

The Buyer agrees to the humane treatment of this lagotto at all times (HOW addendum 2). This includes properly providing for its mental and physical health through training (intermediate obedience,) socialization, proper housing.

The buyer agrees that they will not use outdoor chains or tethers without supervision, will contain their lagotto outdoors with proper fencing and supervision. There lagotto will be indoors during inclement weather.

There lagotto will receive proper veterinary care both emergency and preventative. They will feed a premium diet. The buyer will NOT feed any "fish flavored" foods.

Behavioral Deterrent Device

The lagotto is an ancient water retrieving dog. They have been used for hunting and retrieving for centuries. Working dogs are trained using several different methods including electrical stimulation colors. Using a behavioral deterrent device, (electrical stimulation) or pronged collar is permitted when the buyer has been properly trained by a certified dog trainer in how to effectively use such devices. Any violation of the humane treatment clause will result in your lagotto being immediately returned to House Woller. There will be no refund provided to the seller.

Death of buyer

In the event of the buyer's/owner's death, House Woller should be notified as soon as possible. The lagotto outlined in this agree is to be immediately placed into the custody of the buyer's spouse, if and only if, the spouse was living with the buyer and the lagotto mentioned above, at the time of the owner's death.

In the event of the owner's/buyer's death, AND there is no spouse living with the buyer/owner that has been caring for the lagotto, House Woller is to be to be notified. The buyer will include a copy of this contract and their specific wishes with regards to the placement of the lagotto purchased to the executor of their will, within 30 days of buying their lagotto. The lagotto will be placed into the care of the person that is identified in the buyers next of kin form.

House Woller will pay for and provide this lagotto AKC registration to the buyer, if not at the time of the sale, as soon as they are received by the seller. A copy of any secondary club registrations will be provided to House Woller within 30 days receipt for their records.

Puppies Owed Back to House Woller Farm on a Co-Owned Female

Amount of puppies owed back are outlined in the beginning of this contract. All puppies that are due back to House Woller born from a co-owned female shall carry the "HOUSE WOLLER" farm name. Puppies over the "owned back" clause can carry any name the buyer/s chooses.

It is also understood that if buyer desires to use a stud lagotto owned, co-owned, or leased by Seller, there will be no stud fee for the litter.
