FLOWERBED SPONSORSHIP COMPETITION

Flowerbeds will be Judged by TCFA Board Directors

There are 13 Flowerbeds to choose from and Sponsors will be given their choice of which flowerbed they would like to adopt based on a lottery drawn by the Board of Directors at the May Board Meeting. All Sponsorship Entries (form below) must be received by Monday, May 10th. Each Sponsor will choose a flowerbed depending on the order your name is drawn. The following guidelines will be followed, and Fair Special Events Cash Awards (tbd) will be given to 1st, 2nd, and 3rd Place Winners, along with Ribbons and a Plaque that will be displayed at the flowerbed throughout the year:

- Flowerbeds with perennials currently growing may not be removed without approval from Fair Management.
- Flowerbeds that currently have decorative items can remain or be removed by fairgrounds maintenance, depending on sponsors preference; additional items are available on a first come basis or sponsor can supply, items permanently attached will become fairgrounds property, anything else provided by sponsor may be removed after September 15th. Themed flowerbeds are preferred, and keeping with the 100 Year Anniversary Theme will reflect positively when judged; this year's Fair Theme is "Century of Fun in the Trinity Sun".
- Flowerbeds are to be named, and for identification for judging name must be displayed in the garden, garden names must be received in the Fair Office by July 15th, for placement in the Special Events Flyer.
- Sponsor is responsible for garden supplies, cleaning, planting, weeding, decorating, maintaining, etc. flowerbeds from June 1 – September 15, 2021, fairgrounds maintenance will assist with watering as needed, sponsors are responsible for monitoring flowerbeds and informing fairgrounds office if adjustment to watering is required. Flowerbeds will be watered on an average of 3 times a week, sponsor may water if preferred.
- Flowerbeds will be inspected July 1, 2021 to insure they meet TCFA appearance standards, and sponsors will be given the opportunity to correct appearance by July 15th, at which time they may be reassigned or taken over by fairgrounds staff.
- Each sponsor will be given the opportunity to keep their flowerbed in 2022 if the Flowerbed Sponsorship Program is successful.
- The Fairgrounds is a Trinity County Property and no Cannabis Gardens can be allowed.
