I appreciate hearing from you. For your information, I also left a message on your voice mail this past Friday, May 3rd. We are working against a clock to get our 1,800 acres planted and that particular piece of property was scheduled to receive lime spreading tomorrow. I would then also like to follow up with planting corn on this same 15 acres. I was really hoping all of this could have been cleared up by now, but unfortunately it is not. Therefore, I would appreciate your understanding of my dilemma.
