Amana Colonies Hotel Motel Tax Dollars

At the Monday evening meeting of the Amana Colonies Land Use District, the ACLUD agreement with the Amana Colonies Convention and Visitors Bureau regarding the distribution of hotel motel tax dollars was extended until 2028.

Now that agreement will go to the Amana Colonies Convention and Visitors Bureau board for review and signature.

This agreement is to disburse a regulated allocation of the 7 percent tax on the retail price of a hotel room in the Amana Colonies Land Use District known commonly as the hotel motel tax. This tax is collected by the hotels and motels from its customers and is sent to the lowa Department of Revenue which in turn sends it on to ACLUD for distribution.

Since the final quarter of 2021, \$210,005 has been paid to the Hotel Millwright as a tax rebate. This represents 50 percent of the total hotel motel tax collected solely at the Hotel Millwright.

The ACCVB has received \$228,165 in hotel motel tax dollars since the final quarter of 2021. These dollars have paid for Amana Colony tourism marketing.

ACLUD has used its allocation to support its Historic Preservation Grants program, education and administration.

How did this come about? In 2017 before the Hotel Millwright opened, the Iowa Legislature approved a modification to Iowa Code Chapter 423A so that a land use district, (as structured by Iowa law) could place a hotel motel tax question on the ballot. If it passed it could administer the collection and spending of this tax. After the Iowa Legislature passed this amendment to the Iowa Code, the ACLUD Board of Trustees passed a resolution calling for a public measure to be placed on the fall 2017 ballot for a hotel motel tax of 7 percent to be collected. This was passed by the electorate of the ACLUD. It also stipulated that 50 percent of the tax collected for a period of 15 years or a total over time of \$600,000 (whichever came first) solely at the Hotel Millwright would be paid back to Hotel Millwright in the form of a tax rebate to encourage the development of the new hotel in the village of Amana.

The ACLUD Board of Trustees worked out a formula to allow for hotel motel tax dollars collected to be distributed to support Amana tourism marketing, Amana cultural nonprofit marketing and historic

preservation, along with the tax rebate to the Hotel Millwright.

The tax rebate to the Hotel was based on a model used by many cities and counties. For example, both Johnson ad Linn Counties have long used tax rebates to assist investors in large scale hotel or commercial development. Like a TIF district this allows taxing agencies to boost investment long term in one geographical area or neighborhood.

The ACLUD- ACCVB agreement works like this:

- ACLUD receives a Hotel Motel tax revenue check on a quarterly basis from the Iowa Department of Revenue. This check is the amount of hotel motel tax collected by the state in the land use district.
- 50 percent of the total collected at the Hotel Millwright for a period of 15 years or \$600,000 (which ever happens first) will be paid back to the Hotel Millwright as a tax rebate to be used to construct, repair, maintain, operate or upgrade its facilities.
- Of the remaining 50 percent collected: 75 percent goes to the ACCVB for marketing to target areas to boost tourism.
- ACLUD retains 25 percent for historic preservation grants paid directly to Amana property owners and for facilitation/ administration.

Since the passage of the Hotel Motel tax in Amana, ACLUD set up and maintained a Historic Preservation Grant program for grants to Amana Colony property owners of up to 75 percent of the total proiect cost or \$2,500 whichever is less, for restoration or maintenance projects on historic structures. These projects are to be in keeping with ACLUD ordinances and the National Parks Service administration's standards for historic preservation. NPS standards for historic preservation inform all ACLUD policies and rules.

Residents of historic properties in the Amana Colonies have obtained grants ranging in size from \$500 to \$2,500 for the replacement of windows. doors, rain gutters, placement of lanterns and other types of restoration projects and repairs to historic homes and buildings (pre 1932).

The grant application and rules can be seen on the ACLUD website. The deadline to apply is February 1 for 2026 grants. Applicants apply for projects they are planning to do using cost estimates they obtain. Grants are approved by a committee and paid out after the project is done and has been inspected by the ACLUD administrator. Each year another set of grants is approved.

As noted above, since the final quarter of 2021, \$210,005 has been paid to the Hotel Millwright in tax rebates from the collection of the hotel motel tax at the Millwright. Yes, dollars were collected and disbursed before 2021, but the totals as of 2021 were the ones shared at the ACLUD meeting, hence they are in this news report.

The ACCVB has collected \$228,165 since the final guarter of 2021. So roughly \$57,000 has been paid to the ACCVB each of the last four years via the hotel motel tax. By the rules the ACCVB are to use these monies for advertising and marketing of the Amana Colonies. The rules ask that at least 10 percent be used to specifically promote our Amana Colony nonprofit groups and cultural sites.
