a) Category A Grant for CR 519 North ~

The funding amount awarded is \$4,775,321 which is approximately 60% of the estimated costs of the design, construction and inspection for the reconstruction of CR 519 North. The remaining 40% match will be the responsibility of Highland Copper. Highland Copper is responsible for obtaining all applicable final state and federal permits for the Copperwood Project site and all other permits

required for the reconstruction of the roadway. No action was taken.
