#### Financial Overview

- The Parking Authority had YTD revenue as of November 30, 2024 of \$540,233. This is \$47,588 higher than the previous year. Total YTD expenses were \$443,164. An increase of \$5,287 compared to the previous year. Net YTD revenue was \$97,069. An increase of \$42,301 compared to 2023.
- The Park and Ride had YTD revenue as of November 30, 2024 of \$201,669. An increase of \$10,956 compared to 2023. YTD expenses were \$175,457. A decrease of \$22,850 compared to 2023. YTD net revenue was \$26,212. An increase of \$33,806 compared to 2023.
