New FDA Warning - Kratom

The FDA has issued a warning regarding kratom, an herbal supplement that is made from the leaves of a plant (*Mitragyna speciosa*) that grows in Thailand, Malaysia, Indonesia and Papua New Guinea. FDA Commissioner, Scott Gottlieb, MD, has issued a statement addressing the concerns about the increased use of this herbal supplement and potential health risks. In the statement, kratom is being used to treat pain, anxiety and depression. Some people believe they can use

kratom to treat opioid withdrawal symptoms. FDA has concerns the public is using kratom to treat these medical conditions instead of diagnosis and treatment by a licensed health care provider, who could inform the user about side effects and drug interactions. The FDA reports this supplement is being marketed as a "safe" alternative since it is a plant based product. Kratom has similar effects as opioids such as euphoria, abuse, addiction and may result in death. The FDA stated there has been a tenfold increase in calls to the poison control centers regarding kratom from 2010 to 2015 and 36 associated deaths. The FDA warning states: "there are currently no FDA-approved therapeutic uses of kratom. Moreover the FDA has evidence to show that there are significant safety issues associated with its use" (Prozialeck, et al, 2012). The FDA is actively preventing shipments from entering the US. Kratom is a controlled substance in 16 countries and is banned in the following states: Alabama, Arkansas, Indiana, Tennessee and Wisconsin. Other states have legislature pending to ban kratom.

Patients may ask about this herbal supplement or be admitted to the hospital after ingesting one of the various forms. Kratom is available as raw leaves, capsules, tablets, and concentrated extracts which may be made into a tea. The supplement may be purchased from the Internet

or specialty store such as smoke shop, bodegas, coffee shops.
