

EXHIBITORS PLEASE NOTE

1. The building is air conditioned and heated. Trial grounds will not be available the night before the trial.
2. No dogs will be allowed into the trial grounds except those properly entered.
3. Dogs eligible to enter are those stated in Chapter 3, 4 and 5 of the AKC Obedience Regulations.
4. WWCDTC assumes no responsibility for any loss, damage, or injury sustained by exhibitors, handlers or their dogs or property and further assumes no responsibility for injury to an exhibitor's child. Exhibitors must exercise control of their children at all times while within the trial grounds.
5. Dogs need be present only for scheduled time of judging and may be removed immediately after judging unless required for further judging. Dogs will be judged in catalog order, to the extent that it is practical without holding up judging in another ring. Judges are not required to wait for dogs and it is the responsibility of each exhibitor to have his/her dog ready at ringside without waiting to be called.
6. All trophies must be claimed at the trial. Unclaimed trophies will become the property of WWCDTC upon the completion of the Trial. Where there is a double entry of the same dog only the highest score will be eligible for special awards. Class awards will be given out at the conclusion of the judging of the class; all other awards will be given out after all judging has been completed.
7. As you are aware, securing suitable show facilities is not easy. Help keep our show site clean by picking up after your dog.
8. No private exercise pens are permitted in building. Use designated exercise areas only.
9. All crates and chairs must be placed on mats.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).

2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.

3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.

4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

Telephone and telegraph entries cannot be accepted. No entry will be accepted which is made subject to conditions.

Bitches who come in season after the closing date will have the entry fee less \$5.00 refunded upon written certification by a licensed veterinarian to the effect that the bitch in question is in season on the day of the trial. NOTIFICATION MUST BE RECEIVED BY THE TRIAL SECRETARY BEFORE 8 A.M. (CST), THE DAY OF THE TRIAL.

Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by veterinarian or judges, or barred from competition by action of the Trial Committee. If, because of riots, civil disturbances or other acts beyond the control of the Trial giving Club, it is impossible to open or complete the Trial, no refund of entry fees will be made.
