The term of this agreement shall commence on the date this agreement is signed by the tenant, and shall continue thereafter until the tenant provides written notice. Written notice must be made at least 15 days prior to the tenant removes the boat, motor home, trailer and/or recreational vehicle described hereto (Hereinafter "Property") from the premises of Acres Aweigh. Property may not be stored on the premise of Acres Aweigh until a complete and signed contract has been submitted to Acres Aweigh. Current License Plate information is MANDATORY.

In consideration of storage payment, Acres Aweigh agrees to store the property as described in this agreement. Contracts are for a minimum of one year, unless otherwise noted. Owners with an annual contract have the option to make payments in annual, semi-annual, or quarter increments and agree to make payments for a minimum of one year. Rates are based on lot size, property size, length of rental period and payment schedule. All rates are paid in advance. Some payment schedules require a one-time administrative fee of \$40.00. All rates are subject to Ohio sales tax of 7.0% and are not refundable. Owners who enter into an annual contract, no matter payment increment, shall pay the month-to-month contract rate if the property stored at Acres Aweigh is stored less than one year. Owners with short term or seasonal contacts must pay in full at time of initial contract. Owners who do not sign up for automatic payment withdrawals (ACH or Credit Card) using Acres Aweigh's program will be charged a \$5.35 Service fee with each invoice statement. Please note that the auto pay transaction description will reflect transaction by U-Haul and not Acres Aweigh Storage as we use a U-Haul computer program for processing our accounts. Acres Aweigh has the right to change storage rates at any time. There is a \$35.00 charge for any NSF checks. Acres Aweigh may charge a late fee for any late payment or require full annual payment. Owner will be charged for storage rental until proper written notification of property removal has been submitted to Acres Aweigh. All storage charges must be paid in full before the property is removed from lot. Acres Aweigh shall have the right to retain possession of the vehicle until all charges and cost incurred under this contract agreement are paid in full. Acres Aweigh has the option to have the property towed from the premises at the property owner's expense if storage payment is not made or place a lien on the property.

Access to property is available 24 hours weekdays and weekends by combination. The storage agreement covers outside storage and only the rental space sufficient to store one vehicle per space. Property owner releases all claims against Acres Aweigh property owner(s), representatives, agents and employees from any and all damage or loss to property or its contents, including, but not limited to, theft, vandalism, fire, windstorm, flood, hail, tornado, weathering, acts causing personal injury, and any other injury or damages while property is stored at Acres Aweigh beyond the control of Acres Aweigh. Acres Aweigh will not be plowed for snow removal. This storage agreement does not include storage insurance. The owner shall be responsible for insuring the property and its contents while stored at Acres Aweigh.

The following conditions must be adhered to:

- 1. Notify Acres Aweigh of any change of address, phone number, email address, ownership of property or any other pertinent information.
- 2. Park property only in the numbered space/lot assigned by Acres Aweigh.
- 3. Property must be in working order and with no flat tires while stored at Acres Aweigh.
- 4. Property must be lawfully licensed and titled at all times while stored at Acres Aweigh.
- 5. Do not discard trash on the premise of Acres Aweigh.

By signing below, the property owner has read this storage contract agreement & understands that storing property at Acres Aweigh is at his/her own risk. The owner further understands that it is their responsibility to pay by the rent due date & that failure to pay rent on time may result in automatic late fees & possible eviction or lien on property.
