RE: FOLLOW-UP TO OBSTRUCTION OF JUSTICE

DEAR DIRECTOR COMEY,

I AM SUBMITTING THIS ADDITIONAL INFORMATION AND DOCUMENTATION SUPPORTING MY ALLEGATIONS AND PREVIOUS CORRESPONDENCE TO YOU.

THIS WOULD HAVE BEEN A LITTLE MORE TIMELY EXCEPT TDL PERSONNEL J.D. SEIGLE, RAYMOND HERITAGE, THOMAS BOUGHNER, ROBERT HERRERA, BRAD LIVINGSTON AND OTHERS ILLEGALLY CONTINUE TO RETALIATE AND INTERFERE WITH MY ABILITY TO COLLECT AND PRESENT THIS INFORMATION TO YOU AND CHIEF JUDGE, RONALD B. KING, BANKRUPTCY COURT, WESTERN DISTRICT OF TEXAS, AND OTHERS.

THIS INFORMATION SUPPORTS MY FORMAL CRIMINAL COMPLAINTS REGARDING PUBLIC CORRUPTION, CRIMINAL COVER-UP AND OBSTRUCTION OF JUSTICE - CRIMINAL INTERFERENCE IN THE INVESTIGATIONS OF: RETALIATION AGAINST A WITNESS; CRIMINAL INTERFERENCE WITH A BANKRUPTCY PROCEEDING; ESPIONAGE (INVOLVING YOUR OFFICE); ATTEMPT TO COMMIT MURDER OR MANSLAUGHTER; TAMPERING WITH EVIDENCE; TAMPERING WITH A

WITNESS; DESTRUCTION OF AN ENERGY FACILITY; DESTRUCTION OF NATIONAL DEFENSE MATERIAL; DESTRUCTION OF A NATIONAL DEFENSE UTILITY; DESTRUCTION OF WAR MATERIAL; DESTRUCTION OF A WAR UTILITY; INTERFERENCE WITH INTERSTATE COMMERCE; INTERFERENCE WITH INTERNATIONAL COMMERCE; SABOTAGE, AND CONSPIRACY.

THERE IS A "REASONABLE POSSIBILITY" MY STATE TRIAL JUDGE WAS BRIBED FOR DECISIONS, RULINGS AND ORDERS IN MY STATE CASE AND THAT OF MY CO-DEFENDANT, MARY JO WOODALL. THIS IS RELEVANT BECAUSE THE FEDERAL COURT IN AUSTIN TOOK SAGE'S DECISIONS, RULINGS, AND ORDERS AND DENIED ME HEARINGS AND PROCEEDING BECAUSE OF THEM.

IN MY FEDERAL SUPPRESSION HEARING IN AUSTIN, TRAVIS COUNTY SHERIFF'S DEPUTY TONY MILLER, DA INVESTIGATOR LORI CARTER, JONESTOWN RESIDENT'S SHELBY THOMAS AND HIS MOTHER TESTIFIED. THE STATE SEARCH WARRANT AFFIDAVIT'S RELED HEAVILY ON STATEMENTS BY MILLER, CARTER AND OTHERS. THERE ARE OVER 65 PATENTLY FALSE STATEMENTS IN THOSE AFFIDAVITS AND THE THOMAS' COMMITTED PERJURY.

THE THOMAS' ARE PERSONS OF CONTROVERSY IN THE IN-ALL-PROBABLE BRIBERY OF THE STATE TRIAL JUDGE, KAREN SAGE (SEE FORMAL CRIMINAL COMPLAINT NOV. 22, 2014), AND OTHER LISTED CRIMES, WHICH NOW

INCLUDES SHELBY THOMAS' MOTHER, WHO PERJURED HERSELF IN TESTIMONY REGARDING COMMENTS I ALLEGEDLY MADE TO HER. SHELBY AND HIS MOTHER

ARE SUBJECT TO LONG TERM FEDERAL PRISON TIME IF CONVICTED ON ANY OF THESE CRIMES. THE CRIMINAL PERJURY BY MRS. THOMAS AND HER RELATIONSHIPS TO JONESTOWN MAYOR, DEANIE ARMSTRONG, RESIDENTS MILTON AND PAUL ALLEN, RICK VANDERSLUIS, AND OTHERS, FURTHER SUPPORTS MOTIVE, MEANS, AND OPPORTUNITY TO BRIBE KAREN SAGE TO ENSURE THE JONESTOWN WIND PROJECT FAILED.

PAGES 1-20, ATTACHED, SUPPORTS THE FACT JOHN KARLSON, TOBY MILLER, JUSTIN SHEPARD, AND OTHERS MADE PATENTLY FALSE STATEMENTS, AND THOSE THAT TESTIFIED COMMITTED PERJURY TESTIFYING THE TECHNOLOGY DID NOT EXIST, AND THAT THE SYSTEMS DID NOT WORK.

IN 2009, CM ENERGIES, WHILE STILL OUT AT THE U.T. JJ PICKLE CENTER, PURCHASED SEVERAL WINDBLUS POWER ALTERNATOR'S (PMA'S) (SEE PAGES 1 AND 2), TO INSTALL IN THE SYSTEMS AT THE PICKLE CENTER.

EARLY TESTING DEMONSTRATED A DIRECT SHAFT DRIVE WAS UNABLE TO GENERATE ANY POWER. HOWEVER BY ATTACHING A GEARING SYSTEM, THESE PMA'S COULD BE USED TO GENERATE POWER. THE WINDBLUS PMA'S PURCHASED ARE 5KW (KILOWATT) GENERATORS. SIMPLY BY CONNECTING MULTIPLE GENERATORS TOGETHER ELECTRICALLY, WE TOOK AND INCREASED THE OUTPUT CAPACITY TO OVER 15KW.
