**CONTRACT FOR RETAIL DEALER**  
**(INDOORS) 3 pages**

This contract governs the space, allowing for the demonstration, display and selling of lapidary merchandise, fossils, and/or gems and minerals, and shall be binding upon the endorsement by the El Cajon Valley Gem and Mineral Society, Inc., hereafter called the HOST, and \_\_\_\_\_  
Hereafter called the DEALER.

WHEREAS, HOST is conducting the above show on the dates set forth above on the premises known as the Lakeside Rodeo Grounds at 12584 Mapleview Street, Lakeside, CA. Where all the retail booths will be located. The show will open to the public at 09:00am both days and close at 5:00pm on Saturday, November 18th and close 4:00pm Sunday November 19th, 2023.

NOW THEREFORE, in consideration of the premises and mutual covenants herein contained, the parties hereto understand and agree as follows:

- 1) HOST shall conduct said show on the dates, during the hours, and on the premises as specified above, unless conditions beyond the control of the HOST force cancellation.
- 2) HOST shall provide all contracted tables and two chairs
- 3) HOST shall furnish one standard plug-in outlet for each DEALER. All power provided shall be 110 volts, 60 cycle. The HOST will provide no other electrical equipment.
- 4) HOST shall provide security throughout the show. The inside sales room will be locked as soon as the last dealer leaves for the evening and reopen in the morning at 7:00am. The gate entering the Rodeo Grounds will be locked each evening and reopen in the morning to provide additional security.
- 5) Neither the HOST nor any volunteer nor any organization that assists the HOST assumes any liability whatsoever for the personal safety or loss due to pilferage, fire, or any other cause whatsoever. DEALER at own expense may carry insurance to cover such contingencies.
- 6) HOST reserves the right to eliminate any exhibit or portions thereof, or any person, advertising, or any other feature or practice which in the HOST's opinion is objectionable or inconsistent with show décor.
- 7) DEALER hereby agrees to indemnify HOST and helpers harmless from and against all claims for losses or liabilities arising out of the space assigned, or in any connection

with the installation & removal of his/her equipment or materials.

**8) DEALER may start setting up Friday November 17<sup>th</sup> at 1:00pm. Tear-down must be completed by 7:00pm Sunday November 19th.**

9) DEALER must comply with all state laws and local ordinances; however, HOST will purchase the business license required by the county of San Diego.

10) DEALER agrees not to give, assign, share or sell any rights to assigned space without written permission of the HOST.

11) DEALER agrees to use care in handling equipment furnished by the HOST and to do nothing that will damage or deface the floor or walls of the facility. No lapidary equipment using oil or water emulsion can be operated without a floor covering to collect spills, etc. DEALER agrees to pay for any damages he/she causes.

12) DEALER agrees to exercise good safety practices in the protection of the public and to assume the responsibility of his/her negligence.

13) Per Lakeside Rodeo Grounds ordinance, no glass bottles or alcoholic beverages are allowed on the premises.

14) DEALER agrees to restrict electrical usage to 1000 watts maximum. (ten 100-watt bulbs)

15) DEALER agrees not to misrepresent, even slightly, any material for sale.

16) All synthetic, man-made, treated, or constructed material must be plainly marked so the public realizes exactly what it is. Handcrafted articles shall not be represented as to have been made by other than those who did the work. Less than full and accurate representation will subject DEALER to closure his/her space without recourse or refunds, unless immediate corrective measures are taken to the satisfaction of the HOST committee.

17) Due to limitations HOST cannot alter the sales table layout. **DEALER may add an additional table or display case as long as it fits within the space provided.** The DEALER shall provide table cloths for each table. Your allocation space and tables are as follows:

**\*The assigned space shall have 3 eight foot by two-foot tables at \$250.00 for both days. An extra six-foot table is available for \$15.00 each.** Tables do not have traditional legs for risers.

\* If you would like more or less space, please contact Cheryl Boney to see if we can arrange it.

18) DEALER shall return one copy signed by the deadline of **September 1, 2023** with at least 50% of total space rental to Reservations Chairperson. However, spaces will be assigned on a first come basis.

19) DEALER will retain second copy of the contract.

20) Balance, if any, of the space rental shall be received by Reservations Chairperson by October 31<sup>st</sup>, 2023. No refunds shall be made after October 1<sup>st</sup>, 2023 except in cases of emergency and contingent, further, on availability of replacement dealer.

21) Failure of DEALER to perform the conditions and covenants herein contained shall cause forfeiture of any sums paid.
