

TOWN COUNCIL MEETING

June 21, 2021

The Town Council met June 21, 2021, at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight called the meeting to order at 6:00p.m. Council Member Crumpton gave the invocation.

Mayor Hight asked for approval of the Council Minutes from June 7, 2021, as presented.

Council Member Littleton moved to approve the Council Minutes from June 7, 2021, as presented. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman, Benson and Crumpton.

New Business

Jeff Wilcox with Spire presented the Town with the Silver Shovel award for having no incidents for 2020. He thanked the Council for the Public Works outstanding job they are doing.

Mayor Hight presented Ordinance No. 06/21/2021 (Grease Management). Mayor Hight we are having some problem with the sewer stopping up due to business not using grease traps.

Council Member Chapman moved to approve Ordinance No. 06/21/2021 (Grease Management). Council Member Benson seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman, Benson, and Crumpton.

Department Heads

Chief Barnett reported to the Council that in the new employee handbook Article 2-Section 5- Relatives in the local government, states that no employee shall supervise a member of his immediate family. He reported that Riley Barnett is a part time police officer and asked the Council if they would grandfather him in since he was hired by Chief Prady.

Council Member Littleton moved to approve any part time already on the books will stay the same going forward. Council Member Benson seconded the motion. The motion carried with votes being as follow: Yeas: Council Member Littleton, Chapman, and Benson. Absanted: Council Member Crumpton.

Chief Barnett gave the Council a copy of his activity report for May and stated he had already contacted CRX about July 4th celebration on June 30th.

Daniel Avery reported that the tractor should be delivered tomorrow from Clanton Tractor. He also reported that Jeff Lockhart had resigned.

Mayor Hight stated they would advertise Jeff Lockhart's position and he also asked the Council for the approve of a seasonal person due to 2 people being out. The seasonal pay will be \$13.00 an hour. He reported that Justin Price just came back to work today.

Council Member Benson moved to approve the seasonal person. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman, Benson, and Crumpton.

Daniel Avery reported that the garbage truck needs tires, and he has found some that a guy has 12 tires he can get for \$425.00 each, but for that price we must purchase all 12.

Council Member Littleton moved to approve the purchase of 12 tires for garbage truck for \$5100.00. Council Member Chapman seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman, Benson, and Crumpton.

Town Clerk Crystal Smith reported the next Council meeting falls on a Holiday, she asked the council if they wanted to reschedule for July 6th or only have one meeting in July.

Council Member Benson moved to only have the seconded meeting in July (July 19th). Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Chapman, Benson, and Crumpton.

Mayor Hight reminded the Council of the July 4th celebration at Richard Wood Park would be June 30th at 7:00p.m. and he is waiting on the program from Jennifer Curry.

Mayor Hight also reminded the Council of the Master Plan meeting at the Annex Thursday June 24th at 6:00p.m.

Council Member Littleton asked about the CPI bills. Mayor Hight explained they are for the wells and Jemison tank.

Council Member Crumpton moved to approve the transfer of funds, and bills for June 21, 2021. Council Member Littleton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Littleton, Benson, Chapman, and Crumpton.

There being no further business to come before the council, Council Member Littleton moved to adjourn. Council Member Crumpton seconded the motion. The motion carried with the votes being as follow: Yeas: Council Member Crumpton, Benson, Chapman, and Littleton.
