Approve August 27, 2024, Regular Town Meeting Minutes—Mayor Meche Jamie Huval moved to approve the August 27, 2024, Regular Town Meeting Minutes seconded by Kris Brasseaux and Debbie Kidder, motion carried.

Approve Budget to Actual/Budget Comparison for August 2024—Mayor Meche

Debbie Kidder moved to accept the Budget to Actual/ Budget for August 2024 seconded by John Taylor and Jamie Huval, motion carried.

Utility Report—Mayor Meche

A report was handed to the Mayor and Board Members prepared by Todd Abshire.

<u>WATER</u> – The water meter change-out program is moving forward. Thus far, approximately 980 meters have been changed with another 60 or so left to be

changed. We look forward to the new meters saving man-hours and offering better answers regarding customer usage using the new technology. The entire water system is scheduled to be flushed during the month of October. The monthly Safe Drinking Water Act daily chlorine residual logs were verified by Todd Abshire and are on file in the utility office as required by law.

WASTEWATER – The #2 blower is Inoperable. A new motor will be installed in the very near future. The sewer plant is currently supplied with air through the #1 blower. The monthly flow records were faxed to HoPak Laboratories to very flow is in accordance with our discharge permit, as well as all analytical results being examined, reported, and filed in the utility department files.

GAS - A 1" steek gas line scheduled for replacement with a 1" polyethylene line on Oscar Rivette Road. We are awaiting 2 new valves (one for each side of the road). Once the valves arrive, the old steel line will be removed, and the new PE line will be put into service. The gas system is operating at 40 psi of inlet pressure at the Cypress Station and Koch Station.

Police Report—Chief Josh Ross (Absent)

Mayor Meche read a report prepared by Chief Josh Ross.

I would like to first off thank the officers with the Arnaudville Police
Department for their assistance and swift response in the preparation of
Hurricane Francine. While our area did not sustain any damage, the Officers
showed they were more than ready and willing to assist the community when
needed by assisting with preparations around the town, assist with loading
and delivering sandbags to our seniors, critical businesses, and persons with
ailments and disabilities. I would also like to thank the Officers who came out
to support the Arnaudville Volunteer Fire Department's annual black pot cook
off.

As of September 20, 2024, Arnaudville Police Department has successfully prepared well over 300 reports, which consist of various calls from town Ordinance violations, traffic, crashes, misdemeanor arrests, and felony arrests.

The Arnaudville Police Department has processed a total of 8 traffic citations in the past 3 weeks, one (1) felony arrest for crimes against a juvenile, two (2)

misdemeanor arrests, and one criminal citation for illegal burning, which resulted in a structure fire within the town limits.

The current state of the department is as follows:

Staffing: We currently staff 5 certified Police Officers, including myself. We are working to fill a vacancy.

<u>Training Update:</u> Every officer employed by the Arnaudville Police Department is current on their POST required training for 2024, and all have exceeded the mandated minimum number of hours, by more than double.

<u>Vehicle Update:</u> The Arnaudville Police Department is made up of four Police SUV's and three Police Sedans, all of which are in working order.

Community Concerns: Hurricane Season is upon us. The Arnaudville Police Department does have a plan to ensure the town is protected and streets are clear, should we experience a Hurricane. We would like to take this time to remind people to test their generators, ensure they have a carbon monoxide detector installed, and be mindful that now is the time to prepare, not the week or day of. Should any citizen require assistance, they can reach out to the Arnaudville Police Department or Arnaudville Fire Department.
