The aggregate is to be from the Township's stock pile and is to be spread in accordance to State Specification 409 and is to include the loading, hauling, spreading by self-propelled spreaders, and compacting by appropriate rollers. The roads are to be cleaned with a self-propelled broom before sealing begins. All traffic control and signage is the responsibility of the contractor. Job to be completed by October 1 2025.
