July 2005, Attorney Todd Weglarz, Attorney Len Johnson (arrived later than me) and I attended a Facilitation at ex-Judge Kaufman's office in Farmington Hills, At that time, Harper Hospital was offering \$200,000. Dr. James Glazier offered nothing. And, Dr. John Barnwell offered \$25,000. Mr. Weglarz informs Judge Kaufman that we are too far apart in the settlement amount.

When Mr. Johnson arrives, Mr. Weglarz asked to speak to Mr. Johnson out in the hallway (away from my ears). When they both arrived back in the room Mr. Johnson mentions something about deductions. Mr. Weglarz mentions that they were expecting \$1.2 million dollars (I never knew the dollar amount, never asked about it and the law firm never mention it to me.). Mr. Weglarz states he is ready for a trial and Harper University Hospital wants to avoid going to trial. I left that meeting expecting to settle this case with a trial. I was informed that Mr. Weglarz and Mr. Johnson or Mr. Fieger would join me at the Settlement hearing.

August 31, 2005, I thought the Settlement hearing was to announce that we will go to trial. Attorney Weglarz was not at the hearing. Attorney Johnson informed me that Judge Baxter asked him to convince me to settle. And, that she wanted to tell me herself. In the chamber, Judge Baxter informed me that she did not wish to sit through a three week trial. And, my case for the doctors were weak. And, Judge Baxter said to me that I wanted my pound of flesh. I thought that meant that I wanted a trial so I said yes. I told Judge Baxter that I wanted a trial. Then Judge Baxter related two stories to me. The first about what is not her job and having an X on her record. And, the doctors do not want an X on their records. My husband bled to death. Henry bled for two-three days. IT WAS SOMEONE'S (SEVERAL PERSONS) JOB TO TAKE CARE OF MY HUSBAND AFTER SURGERY. A JURY CAN DECIDE WHO SHOULD HAVE AN X ON THEIR RECORD FROM THE FACTS OF THE CASE. The second story is about Jewish merchants and everyone else had to play by their rules or something to that effect. ATTORNEY JOHNSON JUST SAT THERE. I HAD NO ATTORNEY OR JUDGE IN THIS CASE. I DID NOT KNOW WHAT TO DO. THIS CASE SETTLED FOR \$500,000. THIS CASE WAS DECIDED BEFORE I EVEN WALKED INTO THE COURTROOM.

ADDITIONAL INFORMATION:

- 1. I informed Judge Baxter that Todd Weglarz was my attorney. She asked Mr. Johnson whether he was the trial attorney. Mr. Johnson replied yes. And, he stated that Mr. Weglarz was in court. I was wondering why Mr. Weglarz was not with me? And, why this Settlement hearing was not postponed until Mr. Weglarz was available to handle this medical malpractice case. This Settlement hearing has been postponed a few times.
- 2. I mentioned that when my husband coughed on the day of the surgery blood appeared on his gown. Dr. Barnwell's assistant came to apply pressure for 10 minutes. Judge Baxter was unaware of the assistant. She asked Attorney Johnson if the assistant was deposed. He did not know. Judge Baxter did explain that the other attorney did not inform her of the assistant. However, the impression that I got was that all of them wanted to protect the attending physician, Dr. Glazier and to make Dr. Barnwell the fall guy. My husband came through the surgery. And, Dr. Barnwell was the only one who stepped up to show any kind of responsibility in the death of Henry even though he was not the attending physician. Dr. Barnwell is a true health professional. Everyone else has the "it was not my job attitude".
- 3. Upon Judge Baxter telling me that it is not her job to ask someone in her courtroom to be quiet and etc. I stated that I heard "it is not my job" while working for the City of Detroit for 28 years. And, I told Judge Baxter that it is was not Michelle Bradley PCA job to look after my husband but she did. Michelle Bradley is a strong witness in this case.
- 4. In addition, I informed Judge Baxter that it took me two weeks after my husband's death to retain an attorney. I had never thought about suing. This lawsuit came about because Harper University Hospital refused to inform me as to what happen to my husband. I called the CEO Dr. Porter twice. No response. I called others and went to see one person. Still no one would disclose what happen to my husband.

5. All of ours and the other parties' attorney conversations were held in Judge Baxter chamber not in open court.
