 - Sec.10, That a special assessment is hereby made on all Lots and pieces of ground in Sewer Distret Np.1 Liable for special sewer assessments for the purpose of paying one-tenth of the original assessment and six per cent interest for one year on eight-tenths of the original assessment.
 - Sec. 11. That a special assessment is hereby made on all lots and pieces of ground in sewer District NO.2, liable for special sewer assessment for the purpose of paying one-tenth of the original assessment and six per cent interest for one year on Eight-tenths of the original assessment.
 - Sec. 12 That a special assessment is hereby made on all Lots and pieces of ground in Sewer District No. 3. liable for special sewer assessment for the purpose of paying one-tenth of the original assessment and six per cent interest for one year on Eight-tenths of the original assessments.
