

ORDINANCE No. 572

An Ordinance to levy a corporate tax and special sewer assessments in the city of Garnett, Kansas.

Be it ordained by the Mayor and Commissioners, of the City of Garnett, Kansas.

Sec. 1. That a corporate tax be, and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for general ^{Revenue} purposes Fifteen cents on each Hundred Dollars valuation.

Sec. 2. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for water works purposes Five cents on each Hundred Dollars valuation.

Sec. 3. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for street purposes, Ten cents on each Hundred Dollars valuation.

~~Sec. 4. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Water Works Bond interest purposes cents on each Hundred Dollars valuation.~~

Sec. 4. That a corporate tax be, and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Water Works Extension bond interest purposes Six cents on each Hundred Dollars valuation.

Sec. 5. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Water Works Bond sinking fund purposes Fifteen Cents on each Hundred Dollars valuation.

Sec. 6. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Water Works Extension Bond sinking fund purposes, Five cents on each Hundred Dollars valuation.

Sec. 7. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for main Sewer and Bond interest purposes, Six cents on each Hundred Dollars valuation.

Sec. 8. That a corporate tax be and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for main Sewer and Bond sinking fund purposes, Five cents on each Hundred Dollars valuation.

Sec. 9. That a corporate tax be, and the same is hereby levied on all the taxable property in the city of Garnett, Kansas, for Electric Light and Power purposes, Ten cents on each Hundred Dollars valuation.

Sec. 10. That a special assessment is hereby made on all Lots and pieces of ground in Sewer District No. 1. Liable for special sewer assessments for the purpose of paying one-tenth of the original assessment and six per cent interest for one year on eight-tenths of the original assessment.

Sec. 11. That a special assessment is hereby made on all lots and pieces of ground in sewer District No. 2, liable for special sewer assessment for the purpose of paying one-tenth of the original assessment and six per cent interest for one year on Eight-tenths of the original assessment.

Sec. 12. That a special assessment is hereby made on all Lots and pieces of ground in Sewer District No. 3. liable for special sewer assessments for the purpose of paying one-tenth of the original assessment and six per cent interest for one year on Eight-tenths of the original assessments.

Sec. 13. That this Ordinance shall take effect and be in force from and after ten days after its passage by the Commissioners of Garnett, Kansas, and after its publication in the official paper, (Evening Review) of Garnett, Kansas.
