Painting tank – One estimate was received from Chad Carr in Belle Fourche. 5400 sq feet, pressure wash and paint with loxon paint \$14,850 plus excise tax. Pam made a motion to accept the bid, seconded by Tom Sitzler. Motion carried. A signed contract is needed prior to work being started.
