**Official NCCA Accreditation Statement**

On July 22, 2011, the National Commission for Certifying Agencies (NCCA) granted reaccreditation to the National Board for Certification of Orthopaedic Technologists, Inc. (NBCOT) and the OTC® Examination for demonstrating compliance with the *NCCA Standards for the Accreditation of Certification Programs*. NCCA is the accrediting body of the Institute for Credentialing Excellence (formerly the National Organization for Competency Assurance). The NCCA Standards were created in 1977 and updated in 2003 to ensure certification programs adhere to modern standards of practice for the certification industry. The NBCOT joins an elite group of more than 100 organizations representing over 250 programs that have received and maintained NCCA accreditation. **Continuing Education:**

It continues to become apparent that there are still many certificants that claim to have difficulty obtaining the required 120 CEUs due to the cost of attending conferences and other functions. At this time, each OTC credential holder is only required to obtain forty (40) category 1 credits with the remaining eighty (80) credits which can be obtained in category 2. Please review the current CEU guidelines regarding what is required in each category. You will find:

**CATEGORY 1 Credits:**

CPR – Maximum of 6 credits per 6 year cycle

Item Writing – Maximum of 20 credits per 6 year cycle

Teaching – Maximum of 10 credits per 6 year cycle

Grand Rounds – Maximum of 60 credits per 6 year cycle

If an OTC® were to take advantage of the above CEUs that person would have a total of 96 Category 1 credits. The remainder credits needed could be obtained by completing On-Line CEUs for Category 2 credits. Therefore, obtaining the required 120 CEUs is in fact attainable.
