APPLICANTS FOR THE POSITION OF PART-TIME FIREFIGHTER/EMT MUST POSSESS A CURRENT FIREFIGHTER II CERTIFICATION, HAZMAT OPERATIONS AND INDIANA EMERGENCY MEDICAL RESPONDER CERTIFICATION AT THE TIME OF APPLICATION. IN ADDITION, ALL APPLICANTS MUST BE UNITED STATES CITIZENS, EIGHTEEN YEARS OLD, HAVE A HIGH SCHOOL DIPLOMA OR EQUIVALENT AND A VALID DRIVER'S LICENSE. ALL APPLICANTS MUST MEET THE ADDITIONAL SPECIFIC REQUIREMENTS SET FORTH BY THE DISTRICT AS EXPLAINED IN THE APPLICATION PACKET THAT WILL BE RECEIVED BY INDIVIDUALS WHO SUCCESSFULLY PASS THE WRITTEN EXAMINATION.
