### TEXAS ONE VOLLEYBALL TRYOUTS GUIDELINES

### **Tryouts**

This is the process through which players are chosen for the Texas One Volleyball (TOV) club teams. There will be a number of evaluators for every age group, position, and team depending on the number of players trying out. Tryouts consist of written evaluation and observation of the player's skills, work ethic and their reactions in a game like situations. Our evaluators will also take into considerations the player's prior level of play, competitiveness, coachability and motivation. It is up to the TOV coaches and evaluators to determine how much each aspect affects the player's results to for the best teams.

Private evaluations will be one-on-one with a TOV coach if an athlete is unable to make the set tryout date for her age group. Just as in "tryouts" the same style of evaluations will be used. The player will find out if he or she has been selected for a team after the try out for her age group is complete.

### **Evaluation of Skill level and Team Selections**

At TOV, coaches and evaluators understand that there are differences in opinions and will seek out the suggestions and views of all TOV coaches when making roster choices. Skills, experience, and level are obviously the biggest indicators of an athlete's potential to making the team, and other factors come into play when being selected or placed on a particular team for example; attitude, work ethic and the "coachability" of a player are all taken into account.

#### Playing up

Sometimes athletes may "play up" in age. Although this is rare, it may happen only when it makes 100% sense to the coaching staff and is agreed upon with the player and parents.

#### Movement between teams

In each age group TOV has a certain number of teams. Athletes may have improved over the year, or a coach may need a player to fill a specific position or skill set within their team. Movement up or down between teams is necessary to prevent players and parents from feeling entitled to or complacent with a position on a certain team even if the player demonstrates behavior (lack of growth, discipline, skill development) causing the staff to move them between teams.





### Texas One Volleyball Club Participation Agreement July 2020

### **Section 1: Conditions of Participation**

We, the parent(s)/guardian(s) of \_\_\_\_\_\_\_ (*Player Name*), have read the enclosed information concerning the policies and practice at Texas One Volleyball Club (hereafter called "TOV"). We agree that having been selected for a team allows her to join TOV for the 2020 – 2021 club season. The undersigned parent/guardian agree to accept membership into the Texas One Volleyball Club for the 2020 – 2021 club season.

Membership entitles the player to participate in practice, local tournaments, state tournaments, and out-of-state tournaments that are designated by the staff members at TOV. Equal opportunity to participate will be provided during practice times. However, court time at tournaments is not guaranteed and will be determined by TOV staff and coaches. Players are required to attend all practices, tournaments, and events scheduled for their assigned team. We understand that failure to attend all practices, tournaments, and events scheduled during the 2020 – 2021 club season may result in decreased playing time and the need for additional players to be added to the team.

We understand the rules and have discussed these rules with our athlete. We agree to and will support our athlete while she participates at TOV. We understand that once registered with and having competed in a tournament with TOV, our daughter will be **unable to transfer clubs**.

### **Section 2: Membership Fees**

It is the responsibility of the parent(s)/guardian(s) to provide transportation, lodging, and meals for all Texas One Volleyball and USAV/AAU volleyball events. The parent(s)/guardian(s) must be financially capable of providing these necessities for the player in order for the player to attend all practices, tournaments, and scheduled events for their assigned team.

Unless a player's dues are paid in full by August 1, 2020, a <u>current credit card must be kept on file with TOV</u> when accepting a position on a team. TOV does not keep credit card information from a previous season. <u>Monthly payments will be due by the 5th of every month. There will be a \$25 late fee if received after the 20<sup>th</sup> of each month. All payments should be paid through CRM system, by cash, check, or credit card at TOV facility. All checks must be payable to Texas One Volleyball Club.</u>

You are obligated to pay **ALL** Club Fee's once a commitment has been made to TOV. A commitment is shown after acceptance of a team and the \$600 non-refundable deposit has been made. Texas One Volleyball is making a one-year



commitment to you or your child when you are asked to join a team. Similarly, by accepting this Club Participation Agreement and joining one of our teams, you are assuming the responsibility for paying the required team fees.

Failure to pay in full or to make scheduled, monthly payments will result in the suspension and/or removal from practices and/or tournaments until the payments or a payment arrangement have been made. *Any money paid to TOV is non-refundable*. Any overdue accounts will be sent to collections or filed with Harris County Small Claims Court. The parent(s)/guardian(s) are responsible for all fees associated in the collection process.

The total annual TOV membership costs include: the non-refundable \$600 deposit, the remainder of the Club Fees, Apparel Fees, and Tournament Fees. These membership costs DO NOT include transportation to and from practice or tournaments, hotel costs, or food.

Read, acknowledged, and agreed to by:

A 5% discount on Club Fees, from a balance after deposit, is offered if payment in full is received by August 1, 2020. This full payment discount cannot be combined with other offers.


There will be a 5% discount for the second athlete in the family. This is also true to any other athlete that chooses to play at TOV. This discount can be added on top of the 5% discount if the Club fees are paid in full by August 1, 2020. This full payment discount cannot be combined with other offers.

In the event this obligation is referred to an attorney and/or collection agency, the member agrees to pay these accrued charges with an additional 5% interest rate charged each month.

The undersigned has received, read, and understands and agrees to abide by these regulations of TOV as they now exist and as they may be amended by TOV staff members.

This Agreement is not transferable by the member without the explicit agreement and approval of TOV. Because the damages under this agreement are difficult to ascertain; the parties mutually agree that in the event of a default, TOV is entitled to receive the entire contract balance due as herein. This agreement, together with any attachment(s), will be governed by the laws of Texas, supersedes all prior oral or written representation or communication between the parties. This constitutes the entire understanding between the parties regarding the subject matter of this agreement and may only be modified or amended by a written supplement signed by both parties.

### **Questions & Answers**

**Q**: How will practices be run?

**A:** All practices at TOV will be run by a script developed by the Master Coaches of Texas One. Each coach will receive a copy prior to practice and will have been formally trained in all the skills, techniques and drills used at practices and during tournaments. Teams will share a court in order to increase the number of contacts each player receives, increase the competition within the club, and to utilize the gym's space affectively. Player's will go through specific skills and routine each practice. There will also be specific days focused on competition and strategy.

**Q:** How are team coaches being picked?

**A:** Coaches are selected by their experience, knowledge of the sport, desire to coach, and the willingness to learn. Each coach will go through extensive training throughout the summer that will prepare them for the season. They will continue to have training during the season to ensure they have the best knowledge to coach every player.

**Q:** How many practices are players allowed to miss per season?

**A:** All programs are allowed only 5 absences for the season. (Strength & Conditioning, and Position Training are a part of practice and is MANDATORY).

Excused Practices Include: Death in the family; Illness/Injury (with doctor's note); School Trips (With at least 2 months' notice); and Religious Responsibility. All practices that will be missed need to be discussed with Master Coach and the Club Director.

**Q:** When are tournament dates going to be posted?

A: All tournament dates will be posted by September 2020.

Q: How many tournaments can players miss?

**A:** Players are not allowed to miss any tournaments unless it is for an excused reason listed above. You will be asked to notify the Master Coach and the coach if this comes up. TOV will NOT place a player on a team that cannot commit to all travel tournaments. Players must make Master Coaches aware of all tournaments they will miss prior to team assessments in November.
