# Minutes of Board of Trustees' Meeting

Currently have 1 actuator on standby for emergencies. The blower block has been replaced and is functioning properly. There was a leak in Concord. Two of the lines ran together under the highway and were replaced. Bulk Shed in Concord has been fixed and is operational again. There was an EPA violation for not submitting the OCCT and SOWT along with one of the sampling rounds, which has been resolved. Trustee Barber moved to approve the presented Water and Street report. Trustee M. Brockhouse seconded the motion. The motion was approved by a unanimous roll-call vote of the Trustees, as follows: A. Brockhouse, yes; Luttrell, yes; Barber, yes; Morrow, yes; and M. This ended up being cheaper than ordering the part ourselves. Have not heard back from the contractor whose bid we accepted last month. Will not return phone calls or text messages so will have to find another contractor in order to clean up 611 Railroad St. Trustee A. # Chapin Rescue Squad Report and Chapin Emergency Management Report-

Bryce McCormick submitted a written report. The suspension in 3-H-11 is needing replaced. Fire hydrants have been painted and are good to go. PSI in Green hydrants are 750-1000, Orange 500-750, and Red are below 500. There could be a possible trade of 3-H-99 but once that is rid of, will need a backup non-transport vehicle so that if 3-H-11 is out of service for any reason, they will not lose their licensure with IDPH as a transport agency. Could be anything from a SUV to a fire engine, but the non-transport vehicle does need to have an IDPH inspection and licensure. One of the ideas is to keep the old ambulance, have the markings removed, then pay out of pocket for the power load to be moved, especially if the sale of surplus items is approved. However, it will be in need of a mobile radio which will be several thousands of dollars. Fire pump test will be on October 10. Trustee Morrow moved to approve the presented Rescue Squad and Emergency Management reports. Trustee Luttrell seconded the motion.
