## TOWN COUNCIL MEETING April 2, 2018

The Town Council met April 2, 2018 at 6:00 p.m. in the Thorsby Municipal Annex Building.

Mayor Hight called the meeting to order at 6:00p.m. Chief Barnett gave the invocation.
