# **GBPOA Board & Committee News**

The first Gaines Bend POA meeting for 2023 was held at the Possum Kingdom Chamber of Commerce on Jan 28<sup>th</sup>. There were no changes in Board Officers for 2023.

Our new Property Management provider, PMI Metroplex, became effective on Jan 1, 2023. Please be sure and register at https://pmihoa.com. Yearly assessment payments are due prior to April 1<sup>st</sup>. Avoid late fees by making your payments prior to the due date.

# MAJOR PROJECTS PLANNED FOR 2023

- 1) Migrate to PMI Metroplex as new property management provider (completed)
- 2) Convert to LED lighting at the Mail Center and Trash Facility (completed)
- 3) Repair electrical damage at Lantana boat dock (completed)
- 4) Schedule yearly Fish Fry (scheduled for May 13th)
- 5) Distribute welcome packages to new property owners (ongoing)
- 6) Complete restoration of Rawhide Vista common area
- 7) Revise Gaines Bend Subdivision CCRs to incorporate policy changes and guidelines for short-term rentals.
- 8) Invest in IT software to further improve data management and enhance security for the Trash System and Front Gate.
- 9) Upgrade road and information signage
- 10) Ongoing road repair and maintenance
- 11) Repair Lantana boat ramp entry and pier walkway

# Transition to PMI Metroplex Property Management

All Gaines Bend property owners should have received their assessment invoices for 2023 and a welcome letter from PMI Metroplex with instructions on creating your new account and accessing the Property Management website pmihoa.com. Please email gainesbendpoa.com if you have not received your welcome letter and/or invoice.



When creating your profile on the "My Profile" tab you have the option to share your contact information in the directory listing. This information is only visible to property owners with a valid account so we encourage you to consider sharing your contact information. You can decline to be included in the directory altogether or you can selectively share only your name, address, email address and/or phone number. The Homeowner Directory Listing can be found on the same "My Profile" tab or by clicking the "Directory" icon.



To keep GBPOA in a strong financial position, both now and in the future, the Board contracted a 10-year Reserve Study to assess the replacement costs of all facilities we must maintain.

Annual assessments for GBPOA and RGB property owners increased for 2023. Yearly assessments increased to \$1,000 for those with a residence on their property and to \$850 for all others. These increases were necessary to ensure we can cover the future costs of replacing and maintaining all the roads, structures and facilities within Gaines Bend.

The annual assessments for GBPOA are considered past due if received after Mar 31<sup>st</sup> at which time the Property Management Group will begin assessing late fees. Assessments

may be paid by mail, direct draft or credit card.

NOTE: There is no change to the process that the Reserve at Gaines Bend (RGB) property owners follow when paying their yearly assessments. RGB Property Owners should continue to pay their assessments using the process defined in their RGB CCRs.

### **Video Monitoring**

In the later part of 2022 the GBPOA upgraded all the video cameras and recording equipment used to monitor the front gate and Trash facility. This includes license plate reader (LPR) cameras for vehicle identification and the latest in DVR recorder technology.

This upgrade helps the GBPOA better identify issues with the gate entry/exits and trash compactor operation/usage and gives us better tools for protecting GBPOA facilities. GBPOA board members have mobile access so they can remotely monitor the cameras and review recordings. Examples are shown below:

### Reserve at Gaines **Bend**

Trash Fees will not be assessed, nor will trash cards be issued until an approved residence is constructed on an RGB property (the same as for GBPOA property owners). RGB Property Owners that complete the construction of an approved residence on their property and are current on their assessment payments are entitled to a Trash Card and can apply for Toll Tag Access.

Please contact our administrator, Bobbie Martin, at 940-445-9208 to request a Trash Card. This card will also work on the keypad readers for entrance/exit at the front gate. See gainesbendpoa.com for instructions on how to obtain Toll Tag Access for Front Gate entry.

# **Architectural Control Committee**

All GBPOA property owners will need to contact the Architectural Control Committee (ACC) to acquire an approved building permit. Applicants must pay the appropriate fees prior to beginning construction of a build or remodel.

Rawhide Vista Abandoned Home Construction: This property has recently been sold to a new owner. The ACC has contacted the new owner and requested this structure be demolished. The ACC is monitoring the situation to ensure the demolition takes place.

### Reminders

Construction Site & Roadside

Trash: Our community continues to see increased construction that contributes to increased trash on or near construction sites and to litter along our roadways. Steady, sustained winds just compound the issue. Please ensure your builders and contractors are mindful to maintain a clean work site and properly contain and remove their trash.

We constantly have loose trash blowing out of open truck beds and UTVs onto the roadside. Litter is easily preventable and the ever increasing amount scattered along Gaines Bend Drive is unsightly, irresponsible and disrespects our community. The POA will continue its efforts to control litter but appreciate anything property owners can do to help by picking up and disposing of any trash you come across. Please report any violations you witness by sending an email to gainesbendpoa.com.

The designated drop off area for Appliances is for "Appliances-Only". Mattresses and furniture are not appliances. There is a County Dump available to dispose of these items. Also do not dispose of hazardous materials, like paint, oil and other chemicals in the Trash facility. All actions are being recorded.

**Trash Cards:** Trash cards not only work on the gates at the trash facility but will also open the front entrance entry and exit gates by waving them in front of the respective keypad readers.

Nextdoor: It is highly recommended you join the popular Possum Kingdom community social network, Nextdoor, at nextdoor.com so you and others can communicate and share not only with your neighbors within Gaines Bend but with other neighboring community members that are also registered with Nextdoor like Sportsman's World and The Cliffs. Nextdoor is available in a mobile app.

**Portable Generators:** Please refrain from operating portable generators on RVs.

Boat Trailer Parking & Enclosed Storage: Homeowners with interests in renting a storage unit and/or approved boat trailer spot in the dedicated area in front of storage should contact Gaines Bend Utilities (Shawn Gibson), the owner of the facility that manages this area. No parking is allowed near the Emergency Helipad.

ATV/UTVs, 4-Wheelers & Motorcycles: Please observe posted speeds, insure drivers are of age, and only drive on hardtop roads. Also be mindful that children, walkers, bikers and wildlife share these roads.
