AN ORDINANCE OF THE BOROUGH OF ST. LAWRENCE, BERKS COUNTY PENNSYLVANIA, AMENDING ORDINANCE # 352 "SEWER USE ORDINANCE", SECTION 6 "USE OF PUBLIC SEWERS", SUB-SECTION K.7 TO INCORPORATE A REVISED LIST OF LOCAL LIMITS FOR THE DISCHARGE OF INDUSTRIAL WASTEWATER AND RULES OF APPLICABILITY OF THE LOCAL LIMITS

The Borough Council of the Borough of St. Lawrence, Berks County, Pennsylvania, hereby enacts and ordains as follows:

1. Section 6 Sub-section K.7, of Ordinance 352 establishing local limits applicable to discharges of industrial waste, is rescinded and replaced to establish the following list of local limits.

- a. Local limits applicable to discharges of industrial wastewater shall be as follows:

Local Discharge Limitations

<u>Parameter</u>	<u>Maximum Daily Limit</u>
Arsenic , Total	0.24 mg/L
Cadmium , Total	0.18 mg/L
Copper , Total	0.76 mg/L
Cyanide , Total	0.47 mg/L
Lead , Total	1.39 mg/L
Mercury , Total	0.020 mg/L
Molybdenum , Total	0.24 mg/L
Nickel , Total	2.10 mg/L
Selenium , Total	0.90 mg/L
Silver , Total	1.54 mg/L
Zinc , Total	2.00 mg/L


- b. All prior local discharge limitations applicable to industrial wastes established by Borough Resolution or Borough Ordinance, are hereby rescinded and are void as of August 13, 2009.

2. Effective Date. This Ordinance shall be effective immediately upon passage.




