

MICHAEL BICKELMEYER  
REFLECTION

This discussion is my non fictional personal experience as it relates to my c-corporation, Bugger & Hund. I organized my c-corporation in January of 2002, as a reaction to the 9/11 terrorist attacks on American Soil. It is the imperative to utilize my organization as a non ferrous metal refiner to provide America with the necessary metals to be used in the war on terrorism and drugs. This c-corporation now holds in the way of intellectual property, two United States non provisional patent applications, two provisional patents, and one Federal Grant Application Project with The United States Department Of Agriculture in Columbus, Ohio. To attain these accomplishments required my direct communications with more than 40 Federal Personnel, several Federal Agencies, four Senators at Capitol Hill, and The White House encompassing President George W. Bush and President Barack Obama. The potential of this intellectual property entails glass, plastic, aluminum, copper, steel, and airport systems with steam heated runways, for a minimum of 300 facilities across America's 50 United States.

This culmination of work was comprised of my 40 previous years of work experience in the private sector, 10 of which working for a non ferrous smelter between the ages of 16 and 25 as a labor. This work is coupled with my acquisition of an Associates of Arts Degree, A Bachelor of Science Degree in General Business Administration, and being a Security Academy Graduate where I made the Dean's List. These achievements were obtained before earning my Master of Business Administration Degree in Management.

My first communication after the 9/11 terrorist attacks were directly with President George W. Bush by green card registered, express mail return receipt number EU198915927US on September 20, 2002. My Father Delbert E. Bickelmeyer was a cancer patient in University Hospital in Cleveland, Ohio, when my mailing was received at The White House. My Father died on September 20, 2002, while He had possession of His cell phone in the hospital. I discussed with my Uncle Elwood Bickelmeyer my written communication with President Bush at The White House on September 20, 2002, and my Uncle confirmed that my Father did receive a call from someone in Washington, informing my Father. After my Father was buried my Mother informed me that my Father was going to come home. Perhaps the excitement was too much for my Father to take. I now view President George W. Bush as my new Father. I have the original green card registered return receipt dated September 20, 2002, still in my possession.

I was working in Manufacturing where I had knowledge of fellow employees using drugs, and when I made public knowledge of it, the company increased my work demands to unattainable standards and let me go in December of 2002. This company now has mandatory on the job and periodic drug testing.

I reestablished employment with a Discount Store as a labor 35 to 40 hours a week, and at a Fast Food Restaurant as a cook and maintenance person 40 hours a week. My work in my intellectual property projects became public knowledge, and both my employers increased my physical work duties to a three person capacity. I worked for both employers simultaneously 75 to 80 hours a week for three years.

The Discount Store let me go, saying that they were going to have others replace me in the job, that I had done. I was escorted out of the store by three Parma Police Officers. One of these Officers was Sergeant Spencer O'Roark who I previously rode with in a Police Car with while I was a Volunteer Parma Auxiliary Police Officer for 3.5 years. After exiting the Discount Store and in the parking lot, I turned to Spence and a second Officer. Speaking in reference to my personal intellectual property projects I said, "I run fast and light."

I was let go by the Fast Food Restaurant within two weeks after for spilling a cup of coffee on the floor before the restaurant opened that morning. The three Managers who let me go were later terminated by the Owner, two for stealing, and the third for making sexual advances towards 16 year old girls.

On January 7, 2007 three days after my Birthday I was hospitalized by Judge John Corrigan by court order at the recommendation of United States Secret Service Senior Special Agent Greg Truhan, at the advisement of The Kennedy Family. I was discharged from the hospital on February 23, 2007. My Doctors findings were that I suffered from work exhaustion and sleep deprivations for the third time. The Department Of Defense later overturned all of my employment separations in my favor over The Ohio Bureau Of Employment Services.

I now have several communications of appreciation in writing from President George W. Bush, President Barack Obama, The United States Secret Service, General David Petraeus, and Leon & Sylvia Panetta of The Panetta Institute.
