**REGISTRATION and SET UP INFORMATION** for Arts & Crafts, Antiques & Flea Market, is Friday, October 2<sup>nd</sup> between 1:00 pm and 7:00 pm. Saturday and Sunday 7:00 am to 10:00 am. You will receive your space assignment when you arrive; registration will be in front of the Larowe House. We allow tents only, no Trailers are allowed in the arts/crafts and flea market areas. \* **PLEASE DO NOT SET UP PRIOR TO REGISTRATION**, violators may be asked to leave.

As a vendor/exhibitor, I hereby agree to lease space at the Fall Foliage Festival's Arts & Crafts, Antiques & Flea market show to exhibit and sell merchandise on the 2<sup>nd</sup> and 3<sup>rd</sup> of October 2021, to be held in the Village of Cohocton, NY, 15 South Main Street – Rte 415. I waive and release any and all rights and claims for damage or injuries which may hereafter accrue to me against the Cohocton Development Corporation., it's members, officers, agents of the Village of Cohocton or Town of Cohocton for any damages or injuries which may be incurred by me in connection with my association with entry in or return from said event. Selling directly from any vehicle within or around the edge of the park is strictly prohibited. It is understood all exhibitors will furnish their own tables and/or display equipment, flies or tents. (Sorry, NO electric available and NO use of generators) Approximately 15 Ft of display frontage per space will be allotted each exhibitor. Space approximately 10 ft deep. We ask all our exhibitors to please keep ropes, stakes, products and any display within assigned space. **You are expected to unload your vehicle from the nearest roadway.** All vendors must stay within their spaces marked on the ground. **\*DO NOT PULL YOUR VEHICLE ON THE GRASS! Vendors are responsible for disposing of their own trash.** Failure to do so may result in not being able to return to future events. Please leave your vendor space as you found it!

If you are selling homemade food products, you must send a copy of certificate of insurance and listing Cohocton Development Corp. as additional insured. You must also have proof of a current New York State Permit.

Alcoholic beverages, rummage, or used clothing, pets, firearms, hunting and military knives, swords, unsafe articles, pea shooters, snappers, tirebats, caps, fireworks, satanic paraphernalia, etc. **will not be permitted** on premises, or for sale in exhibit area. Other objectionable items will not be permitted under the discretion of the show committee.
