BUDGET WORK-SHOP The Mayor opened the Budget Workshop meeting at 4:00 P.M., and then read a prepared statement on the budget process and issues specific to the police department. PLANNING AND ZONING BOARD MEBERS Motion Trustee Werts, seconded Trustee Taylor and carried unanimously to appoint Tim Johnson as a Planning Board Alternate member, effective March 11, 2014.

Motion Trustee Taylor, seconded Trustee Zornow and carried unanimously to support the Mayor's appointment of Mark Sheldon to fill the vacancy of Jerry Wage on the Zoning Board of Appeals, effective March 11, 2014.

Motion Trustee Werts, seconded Trustee Blandino and carried unanimously to appoint Jerry Wage to the Planning Board, effective March 11, 2014.

PROPOSED BUDGET FISCAL YEAR 2015 Motion Trustee Blandino, seconded Trustee Werts to accept the Tentative Budget for Fiscal Year 2015 as presented, and for the Tentative Budget to become the official Proposed Budget for Fiscal Year 2015. The Mayor asked for a roll call vote, and the motion was approved unanimously 5-0.
