WHEREAS, Governor Cuomo has eliminated funding from the Aid and Incentives to Municipalities (AIM) program for towns and villages in cases where the funding accounts for less than 2% of the municipal budgets in his \$176 Billion budget proposal which was released on January 15, 2019 and

WHEREAS, this budget proposal eliminates AIM funding for 1,328 of New York State's towns and villages, and

WHEREAS, the elimination of the AIM funding will have a significant impact on municipalities that already have their budgets adopted and in place for 2019, and

WHEREAS, in the event Governor Cuomo's budget proposal is adopted, thirty five (35) of the forty three (43) local municipalities within our county will lose AIM funding, resulting in a hardship and a burden on taxpayers of our county, now therefore it be

RESOLVED that the Randolph Town Board hereby opposes Governor Cuomo's budget proposal to eliminate the AIM funding program for towns and villages where the funding accounts for less than 2% of the municipalities' budgets, and be it further

RESOLVED that the Town Clerk is hereby directed to forward copies of this resolution to Governor Andrew Cuomo, Lieutenant Governor Katky Hochul, Senator Catherine Young, Assemblyman Joseph Giglio, and the New York State Association of Towns.
