

ORDINANCE No. 1010

An ordinance ascertaining, apportioning and levying upon lots, pieces and parcels of ground in the City of Garnett, Kansas, which are liable by law for the costs and expenses, exclusive of such portions thereof as are required by law to be paid by general taxation, the cost and expenses of paving, curbing and improving the following alleys, to-wit:

Alley in Block No. 55 from the east line of Oak Street to the west line of Main Street, and the

Alley in Block No. 47 from the east line of Walnut Street to the west line of Oak Street.

Whereas: The paving of the alleys described in the title of this ordinance were authorized by Ordinance No. 1005 and the construction of these paving improvements have been completed per the plans and specifications, and

Whereas: The total costs of the paving improvements which are chargeable to the property liable therefor have been found and ascertained to be as follows:

Alley in Block No. 55 from the east line of Oak Street to the west line of Main Street

Alley in Block No. 47 from the east line of Walnut Street to the west line of Oak Street

NOW THEREFORE, BE IT ORDAINED, by the governing body of the City of Garnett, Kansas:

Section I. That for the purpose of paying for the paving, curbing and improving of the alleys before referred to in this ordinance, chargeable to the property liable therefor and heretofore found to amount to the following amounts are ascertained, apportioned and levied against the lots, pieces and parcels of ground liable therefor, to-wit:

Alley in Block No. 55 from the east line of Oak Street to the west line of Main Street.

Section II. That the owners of lots, pieces and parcels of ground described in Section Number one of this Ordinance liable for special assessment, as herein provided, may at any time within thirty days after the publication of this Ordinance in the official city paper, pay to the City Treasurer of Garnett, Kansas, the assessment levied against their respective properties above described. Such property upon which said assessment is so paid within the time specified shall not thereafter be liable for further assessment for the costs of such improvement or for the payment of bonds issued therefor. If said special assessment is not paid within thirty days after the publication

of this ordinance, the same can thereafter be paid in ten annual installments as provided by law, and Improvement Bonds as provided by statute, will be issued in the manner and of the denomination, form and interest rates provided by statute.

Section III. That this ordinance shall take effect and be in force from and after its publication in the official paper of the City of Garnett, Kansas.
