Active, Associate, & Senior

- a. An **Active** member is one who has paid her dues and actively participates in Club functions. An Active member must attend at least two business meetings per year, attend an orientation as provided, be a member of a Community Service Committee, participate in one business/program meeting as hospitality, and participate in at least one Club fundraising project.
- b. An **Associate** member is one who has paid her dues and because of her own physical condition or illness, is inactive in the work of the Club. Written request for Associate membership shall be submitted to the Executive Board for approval. An Associate member is excluded from the expectations of an Active member.
- c. A **Senior** member is one who has paid her dues and is excluded from the expectations of an Active member. When she has reached the age of eighty and has been a member of a Federated Club for fifteen years or more, a written request for Senior membership may be submitted to the Executive Board for approval.
