PARKING (excerpt from bylaw 07-04)

- 12. (1) Unless specifically permitted by the other provisions of this Bylaw, no operator or owner shall park or permit to be parked any vehicle on any street or public place for;
 - (a) for any period longer than is permitted by the applicable traffic control device.
 - (b) for more then 72 hours;
 - (c) which interferes with any building access
 - (2) No operator or owner shall park or stand or permit to be parked or left standing the vehicle having a maximum weight of 5,450 kilograms or greater on any street of the Village located in a R1, R2, R3, R4 or PI zone.





2017 Budget:

Council passed the 2017 budget that has maintained a 0% increase of the 2017 mill rate. Assessments for 2017 have increased 4% over 2016 which saw an overall decrease of average assessments of 2.6%. This relates to an assessment increase of only 1.79% since 2015 assessments. Increases are influenced more by new developments rather than changes in individual existing properties, which relates to growth in the community.

Utility disconnection procedures

If you receive a disconnection warning notice (water shut off notice):

- The Village has reserved the right in the Water bylaw No. 2015-007 to shut off water service for non-payment.
- Payment must be made in full once water shut off.
- Absolutely no extensions will be granted.

Payment can be made by cash, debit, or credit card directly at the Village Office. You may pay through your financial institution's online banking system as long as the payment is made by the date and time indicated on the shut off notice. Accounts paid by cheque will not be connected until the deposit has cleared.

- Protect your pipes, appliances and equipment as no further notice will be given prior to disconnection.
- If your water is disconnected, the full outstanding balance along with a \$50 reconnection fee must be paid prior to the service being reconnected.

Services will be reconnected by appointment only. Please allow one to two business days for reconnection.

Property Tax Notices

Notices mailed May 26 2017 .: Payment due by July 31 2017

If you have <u>not</u> received your Notice/s by June 2, 2017 please contact the Village Office at 403-722-3781 to receive a copy.

Tax Arrears

Taxes are in arrears if unpaid after 1 year. This means any unpaid taxes from 2015 and prior are now in arrears. The 2016 deadline is approaching.

If you have received a letter for taxes in arrears, make an appointment with the Village Office to set up a payment plan.

Failure to arrange payment of your taxes will lead to Tax Recovery Services and possible tax sale of your property.
