'Step Six'

"Were entirely ready to have God remove all these defects of character."



He said: **Step six hurts.** There's no way else to put it. It's been the hardest for me to work, and it's even an idea that seems pretty hard to comprehend. To work this step, we pray and ask God to have us become willing to remove our defects. So how do I become willing? Pain. Period.

Early on, I heard a woman talk about the sixth step, and it's been only recently that I understood what she was saying, and what this step is all about. She said, "You can always tell when a person is working a sixth step. They're usually mean, irritable, and hurting. It's because they're looking at their defects." For me, the only way to become "entirely ready" is to suffer from my defects. They have to hurt and cause me pain enough to 1) pray for help, and 2) do something different. I change through pain. I wish I could say I was different and wise, but the truth is pain is the greatest motivator. It works better than anything else when it comes to changing myself.

When I did a fifth step I was able to see patterns of behavior and character defects that had caused me difficulty and pain in the past. But I became ready to give up my defects only after they were staring me straight in the face and I could not avoid them anymore. They weren't working.

In college, after a number of years of sobriety, I was stuck with procrastination to a point so bad that I could not do anything. I wanted to drop out of school. I went to a shrink, prayed about it, but nothing seemed to work. Then I talked to a very wise woman in A.A. who taught me how to work a seventh step. She walked me through that trying time and I made it through that semester. I never would have asked her for help had I not been completely defeated through my own measures. Now, I'm not saying I don't procrastinate. This letter is already past the deadline. But it has never

She said: **This is the step that is** between you and God and the process of daily living.

What I found out in sobriety was that I couldn't continue to do things as I had before, and I really did *want* to do them differently. I began to understand my destructive personality twists by going to AA meetings, listening to others, whose stories were like my own, and doing a 4th step. I realized that I had developed ways of responding to life's obstacles in the past that had simply not worked, not at all.

For instance, when my feelings were hurt I reacted with resentment, re-feeling the hurt again and again. I dwelled on my injuries in a self-sabotaging spiral. My thoughts were like a broken record, screaming out the same negative messages until my nerves were so brittle they would snap. Believe me, I was not the only one who suffered. So did everyone around me.

Anger, fear and resentment had become my weapons of choice. I had used them to fight the world, or else as vehicles in which to flee. What I did not have was patience. My perspective on life was that I was in charge and I never completely trusted a power greater than myself to lead the way.

There are a lot of obstacles within me to being ready to have God change me. Stubbornness, false pride and denial are just a few. But lack of patience is one of the worst. Why should I take the time to ask God to help me? I'll just fix things myself. And I'm going to fix things right now! Yeah, right. If I keep trying to do things my way then I'm not entirely ready for improvement yet. I am still on the path of suffering and I usually just have to hurt enough to be ready to surrender to God.

In Alcoholics Anonymous I have learned a new way to live. I sometimes find myself seeing clearly the wrong path to take and wanting to do things differently, but have no idea how to. That is where faith in my higher

He Said: (cont) gotten that bad again. And if it does get bad I can call my friends, ask for help, and follow the path to freedom. It's also about the faith that the troubling times in my life -- either through my own decisions or what I see as the circumstances of events - have tremendous meaning.

I don't believe that any situation I have suffered through has been in vain. Each one has made me take stock, ask for help to make changes, and come out a different person. And I've seen it in others. I've seen people in A.A. suffer crushing defeats, lose loved ones, not get what they really wanted, or were entitled to. I've seen them come out better, stronger people.

So it's my opinion that Step Six is a straight-up faith step. To me, it's a step where we say, "look, God, you know better than me, so let me become willing in any way that you must. This has to have a meaning. I'm trusting you to show it to me." That's why the 12 and 12 says, "This is the step that separates the men from the boys."

She Said: (cont) power comes in. For me this is the ultimate moment of truth and it brings me to my knees. It is the moment of trust and surrender.

I have to slow things down, recognize my part in a problem and sincerely want to *not* make things worse. I have to take a lot of 'time outs' these days and wait for my emotions to subside.

All of my defects of character were not immediately revealed to me when I stopped drinking. There is a process involved, the process of living. Once I am aware of some new twist in my unproductive behavior I still seem reluctant to be rid of it immediately. Why that is I do not know. But if I am to live at all, it is by the 12 steps of AA. Becoming entirely ready to relinquish my old way of doing things is part of the journey and ultimately leads to a life that is happy, joyous and free.

The Best of Big Book Dave:

June in Our History:

June, 1935: "The Upper Room" is first published coming out once a month with meditation for each day. It was required reading for early A.A. members before our Big Book was written.

June 10, 1935: Dr. Bob, who becomes AA's co-founder, takes his last drink on this date. June 10th is considered by most A.A. members and historians as the birth date of A.A.

June 1938: Bill W. and Hank P. begin slowly putting down on paper what will become our Big Book.

June 1940: Six inmates in San Quentin read a copy of the Big Book together and form the first A.A. group inside a prison. Bill W. was their guest speaker several times.

June 30th, 1941: "The Serenity Prayer" is found in the NY Herald Tribune newspaper by two members and brought into our New York office. Bill W. liked it so much it was reprinted and sent out with all replies to inquiries about A.A. from that day forward.

June 1945: 2500 A.A. members attended the 10th Anniversary of A.A. in Cleveland, reports the Cleveland Press. As of 1945 Cleveland has 14 of 500 A.A. groups in North America.

June 1947: This issue of the Grapevine carried for the first time, the A.A. Preamble, written by the Grapevine's editor Tom Y.

June 1981: Switzerland holds its 25th A.A. Anniversary! Lois (Bill's widow) was one of the guest speakers
