

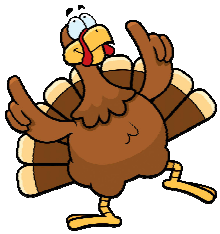

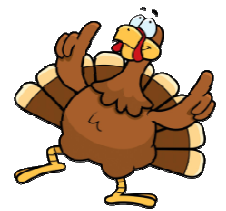

Refund of Pre-entries & Class Changes– Pre-entries will be refunded only upon written request received prior to close of pre-entries. No other entry refunds will be granted. No class changes will be made once day of entries have closed.

Returned Checks-- Any check returned to our bank will invalidate all entries associated with that check. In addition the person writing the check will be reported to ASCA – No Exceptions. Delta ASF will add a \$35.00 Collection fee to the amount of each returned check. Anyone with a check returned must pay all future Delta ASF event fees in cash.

Non Regular: Puppies – 2-4 mo, 4-6 mo, BOBP,

Altered: 6-9, 9-12, 12-15, 15-18, Novice, Am Bred, BBX, Open Blue Merle, Open Red Merle, Open Black, Open Red

Intact: 6-9, 9-12, 12- 15, 15-18, Novice, Am Bred, BBX, Open Blue Merle, Open Red Merle, Open Black, Open Red

Obedience: Utility B/A, Open ODX B/A, Open CDX B/A, Novice C/B/A, Beginner Novice B/A, Sub Novice – Group sits and downs after individual classes. **Obedience is limited to the first 30 entries per show. No entries will be accepted after 30 dogs. No bitches in season are allowed to participate.**

RALLY AWARDS - Ribbons 1st through 4th place, Q ribbons for scores 170 or higher, XQ ribbons for 195 or higher

Rosettes: High Scoring Junior, High in Trial, High Combined Score in Excellent B & Masters B.

DIRECTIONS;

From North: Take Hwy 99 South to Turlock. Exit Fulkerth Avenue, turn left (eastbound). The third stop light will be Golden State. Make a right on Golden State and then an immediate right on to North Front. Go approximately 2 blocks and make a right, cross the RR tracks, right on Broadway and enter through back gate.

From South: Take Hwy 99 North to Turlock. Exit Fulkerth Avenue, turn right (eastbound). Follow above directions.

From the Bay Area: Hwy 580 to 205 East towards Tracy/Stockton. Take I5 North and merge onto CA 120 towards Manteca/Sonora. Exit at Hwy 99 South (Modesto) and continue to Turlock.

Grounds and General Information – Trial will be outdoors on grass. Grounds open at 7am and close at 10pm. For late or early arrival information contact Susan Harris listed above. No designated grooming area however we ask that you keep grooming at least 20 feet from ringside. Electricity is available throughout the fairgrounds with preference given to overnight RV accommodations.

We are all excited for the upcoming show. Please be aware there are several safety and grounds information sheets you should read prior to entering the show. One is below the other is on our Flyer attached.

We are all excited for the upcoming show. Everything is new to us, procedures and grounds, so please be patient while we figure it out. Please be aware there are several safety and grounds information sheets you should read prior to entering the show. One is below the other is on our Flyer attached.

General Practices

1. Clubs, officials and participants are required to follow state, local and facility guidelines that apply to the area and site where the event is held.
2. Be respectful. Not all of our participants have the same level of comfort being out and about at this time. Practice social distancing consistent with guidelines in effect at the time of the event. Avoid congregating to the extent possible.
3. Should you choose to disrupt the show in any way you will be asked to leave. Again please be respectful of others.
4. You will be asked to sign a waiver. Once it is signed you will receive a wristband. You must have the wristband on to be on the grounds.
5. Masks must be worn within 10 feet of any ring. On the grounds, consider wearing masks when in close proximity to others. Delta will provide masks if desired for judges and volunteers. If you are not a judge or volunteer please bring your own.
6. All Rings will have two gates. Entrance & Exit and they will be clearly marked. There will be hand sanitizer at the entrance gate. Please use it prior to entering the ring.
7. Restrooms will be available and will be wiped down twice daily. Wash hands as frequently as possible. We will have disinfecting spray at bathroom facilities for people to spray door handles (or anything else they touch).
8. Avoid shaking hands, hugging, or other physical contact. Avoid touching dogs that are not your responsibility.
9. Avoid common use pens/pencils etc. – You must bring your own pen.
10. Delta will disinfect surfaces in common use areas as often as possible (tables, chairs, doorknobs, etc.)
11. Hospitality, Delta will not be providing hospitality. We will have ice chests with bottled water available. Please be prepared to provide your own meals.
12. Prepare to be self-sufficient: bring sanitizer, bring a generator for electricity, bring personal use masks, bring shade if hot and shelter if raining.
15. Know the armband numbers and class entered for your entries before going to the ring.
16. Do not congregate at the ring or ring gate.
17. While showing your dog, maintain social distances with other exhibitors. We will set spacers along the ring rope 10 feet apart.
18. Be prepared to show your dog's bite.

YOU MUST BRING A SIGNED COPY OF THIS FORM WITH YOU TO THE SHOW OR YOU WILL NOT BE ALLOWED TO ENTER OR PICK UP YOUR ARMBANDS. YOU WILL RECEIVE AN ARMBAND YOU MUST HAVE THE ARMBAND ON AT ALL TIMES.

Waiver of Liability and Informed Consent COVID-19 Waiver

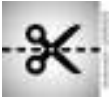
