AN ORDINANCE AMENDING CHAPTER XV. UTILITIES; ARTICLE 3. SEWER OF THE CODIFIED
ORDINANCE OF THE CITY OF MORAN, ALLEN COUNTY, KANSAS

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MORAN, KS

SECTION 1: That beginning with the meter readings of April 1, 2013 sewer rates shall be amended as follows:

15-334. SEWER CHARGES. (a) The minimum charge per month shall be established by water meter size as follows for inside the city limits:

5/8"	16.00
3/4"	17.00
1"	19.00
1 1/4"	22.00
1 1/2"	27.00
2"	32.00
4"	37.00


(b) Residential Accounts: \$4.00 per thousand gallons of water or fractional part thereof of actual usage as determined by averaging use for the months of December, January, and February.

(c) Commercial Accounts: \$4.00 per thousand gallons of water or fractional part thereof of water used monthly.

SECTION 2: Services covered by this ordinance shall be governed by all the rules and regulations now in effect in said city and applicable hereto except such as are modified, amended or repealed by this ordinance.

SECTION 3: This ordinance shall be in full force and effect from and after its passage and publication in The Iowa Register as provided by law.

(c) Commercial Accounts: \$4.00 per thousand gallons of water or fractional part thereof of water used monthly.
